Re: Proposal to Suspend Admissions to the Asia Canada Program

1. Program: Asia Canada Minor (1996) /Extended Minor (2010) program

2. Locations: Courses offered in Burnaby, Downtown and Surrey

3. This minor/extended minor is offered by the Faculty of Arts and Social Sciences

4. Proposed Suspension Date: Summer/Fall 2017

- 5. Reasons for Suspension of Admission
 - a. Lack of enrollment demand: The number of students in the minor and extended minor programs has fluctuated between 16 and 29 in the last five years, with very few extended minors and low enrollment in the upper division.
 - b. Recent enrolments in the minor and extended minor show a decline from 29 (2015) to 24 (2016).
 - c. The faculty complement (one and half full time) is small, and over the years, the expertise of the research faculty has become mismatched with the needs of the program.
 - d. Lower division demand for service courses remains solid.
 - e. New curriculum needs to be developed to reflect changing student demand and increasing diversity in student intake with interest in the Pacific/Asian area.
- 6. Plans for suspension:

- a. In Asia Canada Program steering committee meeting on March 24, all ASC faculty members and the manager, have unanimously recommended to suspend admissions to the Asia Canada Program;
- b. The faculty member and the chair of Department of Humanities has been consulted at the Department of Humanities Retreat on April 24 and the suspension and merging (with the Humanities) plan has been supported;
- c. The program director and manager have identified the courses that need to be offered in the next two years (2016/1017, 2017/2018) to ensure the existing 10 Minors, 3 Extended Minors and 1 Chinese Certificate students have the opportunity to complete the program.
- d. The faculty members and sessional instructors will continue to teach ASC courses during this period.
- e. Further consultation with students and other impacted departments and faculties will be conducted in the coming year (2016/2017)
- 7. Once the suspension of admissions has been approved by FASSCC and SCUS, a notation can be placed in the SFU calendar with wording proposed as follows:

 Admission to the minor and extended minor program has been suspended effective (Date).
