Proposal to Terminate a Program

1. All impacted credentials, levels and categories of the degree, and specific discipline or field of study

Honours: Business (with Term at the Segal Graduate School of Business) Bachelor of Business Administration

2. Location of the program

Segal Campus, Vancouver; Burnaby Campus; Surrey Campus.

3. Faculty(ies), Department(s), or School(s) offering the program

Beedie School of Business, Undergraduate Program

4. Anticipated final dissolution date

August 31, 2017

 - Lack of enrollment demand program has not been offered since 2009.
