That SCUP approves and recommend to Senate the program name change from Development and Sustainability Minor to Sustainable Development Minor, for the School of Resource and Environmental Management within the Faculty of Environment.

Program Name Change

<p>Name of Faculty and academic unit:</p> <p>Faculty of Environment, School of Resource and Environmental Management (Sustainable Development Program)</p>
<p>Current name of program:</p> <p>Development and Sustainability Minor</p>
<p>Proposed program name change:</p> <p>Sustainable Development Minor</p>
<p>Rationale for change:</p> <p>Responsibility for the SD Program and for all SD courses has been shifted to REM and this provides an opportunity to rethink and update the SD courses and credentials to better reflect current thinking about sustainability. We are beginning with the Development and Sustainability Minor. While changes to the Minor’s requirements are submitted separately, we also feel the credential needs a name change to reflect the updates. The current name stems from the merging of the Development and Sustainability (DEVS) and Sustainable Community Development (SCD) programs earlier. The current name for the Minor no longer applies and may even be misleading to students. A name reflecting the name of the sponsoring program would be more appropriate.</p>
