## **Terms of Reference Summary**

These terms of reference for the endowment supporting the Ebco Eppich Chair in Computing Science replace the terms of reference for the Ebco Eppich Expert Systems Endowment Fund supporting the Ebco Eppich Chair in Expert Systems, first established in 1990 with generous gifts from Telus and Ebco Industries among others, and revised in 2008, 2011, 2012, 2014, and 2020. These terms replace all previous iterations.

The Ebco Eppich Chair in Computing Science Endowment will recognize one or more SFU faculty members in the School of Computing Science for their superior scholarly achievements in any sub-area of the field. The successful candidate for the chair will be an internationally recognized scholar in the area of computing science, or, for a junior chair, have the clear potential to make disruptive contributions to the field. The chair will promote excellence in computing science and will carry out a collaborative program of teaching and research. The appointment will be in accordance with Article 42.67 – 42.71 of the SFU/SFUFA Collective Agreement and will be for a five (5) year renewable term. The fund will be administered by the Vice-President Academic and Provost or their designate.

## **Chair and Appointment**

The Ebco Eppich Chair in Computing Science Endowment will recognize one or more SFU faculty members in the School of Computing Science for their superior scholarly achievements in any sub-area of the field. Interest from the endowment will provide a stipend to faculty members to encourage excellence in computing science and will carry out a collaborative program of teaching and research. The use of funds will be recommended by the Director, School of Computing Science, with approval by the Dean, Faculty of Applied Sciences.

Either a senior chair or junior chair may be awarded. A candidate for a senior chair will normally be an internationally recognized scholar who would merit the rank of senior-associate or full professor. They will have demonstrated a continuing commitment to the support and development of emerging scholars. They must have been recognized by their peers in the discipline through the receipt of grants, awards, or other honours. A candidate for a junior chair will be a scholar at the rank of assistant or junior associate professor who has a record of scholarly achievements well beyond that normally seen for a faculty member in that rank and who, based on their accomplishments to date, has the clear potential to make a disruptive contribution to their discipline.

The appointment will be in accordance with Article 42.67 – 42.71 of the SFU/SFUFA Collective Agreement and will be for a five (5) year renewable term.



## **Advisory Committee for the Chair**

The Advisory Committee will be chaired by the Dean, Faculty of Applied Science, who will also be a member of the Committee. The Committee shall meet at least once a year to review the Chair's progress and to advise advise them on future research directions and opportunities. The Committee shall also be consulted at the time of appointment or renewal of the incumbent holding the role of Chair. The Chair should submit an annual report to the Advisory Committee at least one month before the committee meeting. A copy of the annual report shall be adapted and sent to the donor representative at the time of submission to the Advisory Committee. A donor representative will be identified by Eppich family to liaise with the University and Chair holder.

### **Fund Administration**

The Fund will be administered by the Vice-President Academic and Provost or their designate.

The Fund will be invested and the annual spending allocation of the Fund, defined in the University's Endowment Management Policy GP20, will be used each year to support the Purpose. Any unspent spending allocation may be carried forward to another term or academic year, or reinvested in the Fund to protect its value over time. The capital of the Fund will be held in perpetuity.

The Purpose may be amended or supplemented by a document in writing signed and delivered by the parties hereto. For clarity, a personal representative of the Donor will be considered to be a party hereto in the event the Donor is unable for any reason to undertake the amendment of this Purpose.

In the event that the Purpose for which the Fund is established is fulfilled or frustrated and the University, despite its reasonable commercial efforts, is unable to contact the Donor, or their representatives, to amend the Purpose, the University may alter the Purpose provided that any such alteration will be in keeping with the original spirit and general intention of the Purpose.

In the event that the balance of the Fund falls below the University's policy, as amended from time to time, for the establishment of a separate fund, then the capital and any undisbursed income in the Fund may be added to another fund held and managed by the University and applied to a purpose as similar as possible to the Purpose (as amended if applicable). In the event of the winding up or liquidation of the University, the capital and any undisbursed income in the Fund will be distributed in accordance with the University's policies as amended from time to time.

the advice of the Dean, Faculty of Applied Sciences at SFU, who will also chair the Committee. The Committee shall meet at least once a year to review the Chair's progress and to advise them on future research directions and opportunities. The Committee shall also be consulted at the time of appointment or renewal of the incumbent holding the role of Chair. The Chair should submit an annual report to the Advisory Committee at least one month before the committee meeting. A copy of the annual report shall be adapted and sent to the donor representative at the time of submission to the Advisory Committee. A donor representative will be identified by Eppich family to liaise with the University and Chair holder.
