Summary of change: Removal of historical period requirements from the English Master of Arts degree program

Rationale for change: The English Department undertook a proactive review of the graduate curriculum, in order to keep our course offerings flexible and deliverable, and our requirements in line with department strengths. Furthermore, in its response to the 2019 External Review, the English Department, as a whole, committed to considering a revision to the historical distribution requirement for the English MA program. This change reflects this review and allows flexibility in course delivery, simplifies MA student progress through the program, and aligns our graduate program with changes made at the undergraduate level, deemphasizing conventional formations of period and national designation.
