

# SENATE SUMMARY MEETING OF DECEMBER 4, 2023

#### 1. Report of the Chair

The Chair reported that after the previous Senate meeting, she, in her role as President, flew to East Africa to meet with partners at Aga Khan University (AKU) and at the Nelson Mandela African Institution of Science and Technology. Thanks was extended to Naomi Krogman, Dean of the Faculty of Environment, who also joined the trip. SFU is a founding partner of the Arusha Climate and Environmental Research Centre with AKU, and more than 1500 hectares in Tanzania that have been allocated for this facility. The Chair also met with SFU students participating in the inaugural field school at the reserve, studying the impacts of climate change as they relate to a rural setting.

The Chair reported that on the way back from Africa, she stopped in Waterloo to attend the Royal Society of Canada's annual Celebration of Excellence and Engagement, to celebrate SFU researchers who have been named to the Royal Society and also to announce that SFU will be hosting this event in 2024 - themed around community-centered climate innovation.

The Chair reported that SFU continues to face budget challenges, and as result, has initiated a hiring freeze. The University is facing immediate budget pressure in the current year and it is expected that this pressure will rise to approximately \$50 million over the next year. Next year's budget issues are a continuation of some of the current year's pressures, namely lower-than-expected international enrollment, inflationary and unfunded cost pressures, and unanticipated pension plan expense. Thanks was extended to Dilson Rassier, Provost and Vice-President, Academic, who has stepped into a role as Chief Budget Officer to ensure all decisions are being made through an academic lens.

# 2. Report of the Provost

The Provost reported the following updates on SFU's budget challenges:

- For the current fiscal year, SFU is facing about a \$12.5 million shortfall on international student enrollment revenue.
- As a result, a hiring freeze has been put in place and cuts have been imposed on some portfolios.
- For the upcoming fiscal year, SFU is expected to have a negative variance of about \$36 million.
- When combined, that approximates a net estimated deficit of about \$50 million.
- One of the main causes of this variance, besides lower international enrollment, is due to the divestment of about \$20 million of investments, notably in oil companies. That deficit is unrealized, meaning it could potentially be reversed depending on the market, but a loss of about \$20 million is predicted.
- Another factor for the variance is the need to contribute about \$9 million to the staff pension plan, which was not budgeted for in previous years.

• A further factor is SFU's commitment to be a living-wage employer. The budget line for that has increased more than predicted over the past few years, creating an extra budget pressure of about \$4 million.
