#### **Calendar Entry Change for Executive MBA**

Summary of change:

Addition of BUS 694 and BUS 695 and removal of BUS 699.

#### Rationale for change:

BUS 699 is being expanded to include additional sessions after the original 3 day retreat which allow students to continue their learning and build on topics and discussions introduced during the retreat throughout their EMBA program. In place of the previous retreat course, students will take two offerings (one per year) of Building Trust and Collaboration. The original BUS 699 will be replaced with paired courses, with BUS 694 covering Part I of the expanded coursework and BUS 695 is proposed to cover Part II of the coursework. The course focuses on team development and building capacity to address conflicts, improve communication, build trust within teams and organizations, and foster a more inclusive and supportive work environment. To reflect the increased scope of the course, the title and credits have been updated.
