RE: Undergraduate Admission Targets for 1999/00 **DATE**: January 29, 1999

The Senate Committee on Enrollment Management and Planning (SCEMP) is charged with recommending to SCAP annual targets for the admission of new students into undergraduate programs at SFU.

SCEMP met January 27, 1999 to consider the attached proposal for admission targets for 1999/00. The committee approved the proposals with the proviso that the number of students admitted directly from B.C. GRXII in 1999-3 be increased by 120 students from 1,600 to 1,720 and that admission targets from B.C. College and "Others" be reduced accordingly. The Committee felt that this change would soften the abrupt increase in admission GPAs that would otherwise occur for secondary students.

Motion 1.

"That SCAP approve and recommend approval to Senate and the Board of Governors the following undergraduate admission targets for each basis-ofadmission group and for each semester in 1999/00, and that SCAP be delegated authority to make adjustments based on changes to the overall provincial enrollment targets for SFU and based on actual enrollment experience in 1999-2 and 1999-3.

Enrollment Status Report for 1998/1999

SFU was funded for 13,424 full-time equivalent (FTE) undergraduates in 1998/99. This includes an increase of 198 funded FTE, 60 of which were targetted for information technology related courses.

Based on actual enrollments for summer, fall, and spring, I estimate that we will surpass our funded enrollment target by **384** FTE and will report an actual enrollment of **13,808** FTE to the Ministry of Advanced Education, Science and Technology.

Enrollment Funding for 1999/2000

We have received no notice from the MAEST regarding increases to our funded target. We must therefore assume that our target remains at **13,424** FTE and this means that <u>undergraduate enrollments need to decrease by **384** FTE in 1999/2000.</u>

I am proposing enrollment and admission targets for 1999-2, 1999-3 and 2000-1 as follows.

Admission Targets for 1999/2000 by Semester

Allowing for the generation of FTE by undergraduates continuing from previous semesters, my estimate of new students required to achieve the funded enrollment targets for 1999/2000 is as follows:

Table 1 provides a comparison with actual admission numbers from previous semesters. SFU's total intake of new students <u>will have to decline by about 580</u> students in 1999/2000.

As usual, the modeling of the intake targets is constrained to ensure that minimum entry GPAs are stable over the three semesters, historical proportions of new students by basis of admission are roughly maintained, and course supply is manageable in each semester. I have also assumed that retention rates for continuing students, and student course loads will remain unchanged from one year ago.

Admission Targets for 1999/2000 by Basis of Admission and by Semester

Within the global targets identified above, there are, broadly speaking, three groups of students for which separate targets must be identified at this time. These are B.C. Secondary, B.C. College Transfer, and "Other." "Other" includes University Transfer, Degree Holders, Mature, Out-of-Province Secondary or College Transfer, Visiting, Special Entry, Concurrent Studies, B.C. GRXI, B.C. Technical School, etc. Chart 1. provide a historical perspective of admission "shares" by basis-of-admission group.

I am proposing that the admission targets for each group be established as shown below for each of the semesters in 1999/2000.

For B.C. college transfer students with an associate degree, a minimum GPA of 2.00 will be required consistent with Senate policy.

Admission Targets by Faculty for 1999/2000

In 1998 Senate approved the policy of admission of new students to specific Faculties commencing in 1998-3. Separate admission targets for new students are therefore being proposed in 1999/2000 for each Faculty as shown in Table 2. The target for Applied Science is the sum over each of Computing Science, Communications, Engineering Science, and Kinesiology. Note that these are admission targets for new students to each Faculty. Each School also admits many students into its programs through internal transfers. The Education target is an estimate of the number of new-to-SFU students who will be admitted into the PDP/PBD/B.Ed. programs.
