1.3.5 Admission as a Special Student

Normally, a Special Student at the graduate level is a person who has at least a Bachelors degree, or the equivalent, who wishes to take specified courses but is not seeking a degree from this University.

Transcripts of previous university work (or proof of obtaining a degree) will be required at the time of application, but letters of reference will not necessarily be required. Application may be through the Graduate Program Committee in the department in which the student wishes to work or through the Dean of Graduate Studies. Permission is required from the instructor in each course.

No credit will be given towards any degree offered by the University for courses taken as a Special Student except, under unusual circumstances, on petition to the Senate Graduate Studies Committee.

I have copied below the graduate regulation defining Special Student status:

1.3.6 Admission as a Special Student

Normally, a Special Student at the graduate level is a person who has at least a Bachelors degree, or the equivalent, who wishes to take specified courses but is not seeking a degree from this University.

Transcripts of previous university work (or proof of obtaining a degree) will be required at the time of application, but letters of reference will not necessarily be required. Application may be through the Graduate Program Committee in the department in which the student wishes to work or through the Dean of Graduate Studies. Permission is required from the instructor in each course.

No credit will be given towards any degree offered by the University for courses taken as a Special Student except, under unusual circumstances, on petition to the Senate Graduate Studies Committee.

To my considerable surprise, recently there have been cases where students attempted to register as Special Graduate Students in order to enroll in only <u>undergraduate</u> courses. I had thought that the presence of this regulation in the graduate section of the Calendar would have been sufficiently clear as to the intent. I have also noted that no students have applied through my office in the last 11 years, so inclusion of this route of application is clearly unnecessary.

To remedy these (admittedly minor) problems, I am taking the following actions:

- 1. Effectively immediately, Special Graduate Students may normally enroll only in graduate courses. Consideration of requests for exceptions to the 'normally' will require explicit justification. In no case will they be permitted to enroll only in undergraduate courses.
- 2. I shall bring to the Senate Graduate Studies Committee at the next meeting the following motion to clarify the intent of the calendar language and to remove ambiguity about the locus of application.

That paragraph one of graduate regulation 1.3.6. be changed to read: 'Normally, a Special Student at the graduate level is a person who has at least a Bachelors degree, or the equivalent, who wishes to take specified graduate courses, but is not seeking a degree from this University. In no case will a Special Student be permitted to enroll only in undergraduate courses.' And that the second sentence of paragraph two of graduate regulation 1.3.6. be modified to end with the word 'work.'
