- A minimum of 20 semester hours of graduate seminars including at least one of.W.S. $800-5$ or W.S. $822-5$, maintaining at least a 3.0 CGPA, and...


## Rationale:

This would permit students to take either a theory or a methodology course as their required course. Since both theory and methodology are central to Women's Studies and both courses cannot be offered each term, this gives students a chance of finishing their degree in the normal time.
