"That Senate approve and recommend approval to the Board of Governors as set forth in S.86-18, the proposed graduate curriculum changes in the Department of Psychology:

i) From: Application for the General Program

Applicants for the General Program are normally admitted in the Fall Semester. Only under exceptional circumstances will applicants be admitted in the Spring or Summer Semester. Students seeking admission for the Fall Semester must submit all supporting documentation by October 1 or January 1 respectively. The Department reserves the right to admit only those students for whom research space and an appropriate faculty supervisor are available.

Application for the Clinical Program

Applicants for the Clinical Program are admitted only in the Fall Semester. Students seeking admission to the Clinical Program must submit all supporting documents by the preceding February 1st. The Department reserves the right to admit only those students for whom research space and an appropriate faculty supervisor are available.

To: Application for the Experimental & Clinical Programs

Applicants for both the Experimental and Clinical Programs are admitted only in the Fall Semester. Students seeking admission to either program must submit all supporting documentation by the preceding February 1st. The Department reserves the right to admit only those students for whom research space and an appropriate faculty supervisor are available.

Application for the General Program

Applicants for The General Program are normally admitted in the Fall Semester. Only under exceptional circumstances will applicants be admitted in the Spring or Summer Semester. Students seeking admission for the Fall Semester must submit all supporting documentation by October 1 or January 1 respectively. reserves the right to admit only those students for whom research The Department space and an appropriate faculty supervisor are available.

Application for the Clinical Program

Applicants for the Clinical Program are admitted ONLY in the Fall Students seeking admission to the Clinical Program must submit all supporting documents by the preceding FEBRUARY 1st. Department reserves the right to admit only those students for whom research space and an appropriate faculty supervisor are available.

TO:

Application for the Experimental & Clinical Programs

Applicants for both the Experimental & Clinical Programs are admitted ONLY in the Fall Semester. Students seeking admission to either program must submit all supporting documentation by the preceding FEBRUARY 1st. The Department reserves the right to admit only those students for whom research space and an appropriate faculty supervisor are available.

RATIONALE: The Department has found that students applying in the Spring have an unfair advantage -- as they can not be compared with the majority of applicants. In programs where enrolment pressures are high it is extremely desirable to ensure equity, by having only one intake of students.

FROM:

Application as a "Qualifying Student"

Students who have demonstrated competence in Psychology or in other fields but who do not meet the requirements for regular admission may be granted Qualifying status. (Admission requirements for Qualifying Students are outlined in the General Regulations). Transcripts of previous university work, references from qualified time of application. Application deadlines are the same as those for the General Program. Admission as a Qualifying Student does not entail any commitment on behalf of the Department to accept the apply for admission in the usual manner after the qualifying work has been completed.

RATIONALE: The considerable demand for the Psychology graduate programs combined with the high number of fully qualified students who are not accepted into the programs, has resulted in no qualifying students having been accepted for the past several years, and no prospect of them being accepted in the foreseeable future. The deletion of this section brings the calendar in line with current practice.
