1) NEW COURSE PROPOSAL: CN.S. 360-4 Interdisciplinary Readings in Canadian Studies

RATIONALE:

Over the past few years we have received many requests from students for CN.S. 390 and CN.S. 490 topics they would like to see examined from an interdisciplinary point of view. Similarly we receive suggestions from faculty who would like to explore some facet of Canadian Studies from a viewpoint other than can generally be fitted into the conventional departmental course offerings. Occasionally we have been able to use the CN.S. 390 label to accommodate a faculty-directed readings course for an individual student. The result of this has been favourable to both student and faculty member. The use of the CN.S. 390 label is only possible in those semesters when it is not being used for a regular course offering and, of course, limits the student in the further use of this course number.

A directed readings course would allow individual students to examine in depth, a broad range of topics now possible within our program from an interdisciplinary perspective.

It allows for following a course of study within frameworks not normally pursued in departments. We are recommending 4 credits be given for this course as an appropriate number of credits for an advanced, in-depth exploration at the upper levels of a topic. This recommendation also anticipates our planned recommendation that our upper levels offerings be increased to 4 credit hours.

2) Page 71, 1986/87 Calendar:

DISTRIBUTION REQUIREMENTS

To ensure adequate breadth of knowledge regarding Canada, students must complete at least eight required key courses listed below. These must include courses from at least five groups listed.

TO:

#### DISTRIBUTION REQUIREMENTS

To ensure adequate breadth of knowledge regarding Canada, students must complete at least eight required key courses from at least five departments listed below as having "recognized" courses carrying Canadian Studies credit.

RATIONALE:

This change makes it equally possible for students of all departments to undertake double and joint majors with Canadian Studies. It also is an editorial change reflecting the dropping in last year's calendar of groupings of courses for the purposes of ensuring an adequate breadth of knowledge. The phrase "listed below as having "recognized" courses carrying Canadian studies credit" is included to reduce possible ambiguity which might be created by the listing of the courses several paragraphs following this statement.

3) ADDITIONAL COURSES:

The addition of the following courses as 'recognized' courses carrying Canadian Studies credit should be noted:

HIST 484-3 History of Women in North America CMNS 130-3 Explorations in Mass Communication

RATIONALE:

These courses have come to our attention as appropriate to being included as Canadian content courses.

4) DROP:

We wish to remove CN.S. 350-3 - The Francophones Outside Quebec from the calendar.

RATIONALE:

Over the past two years this course has not attracted enough students to warrant its continuance.

5) Page 73, 1986/87 Calendar:

RATIONALE:

This change is required as a result of the dropping of Canadian Studies 350-3.

As noted in the calendar (page 173) under French listings, the course is described as an alternative to FREN 201-3 for franco-phone students.
