Attached please find the proposal form for a request for a change of vector for French 100.

Proposed change: FREN 100-3 (0-3-3) to FREN 100-3 (0-4-2)

Rationale:

The current 3 hours of language tutorial plus 3 hours of language laboratory are proving unsatisfactory. This is particularly so given a) that language laboratories are now not monitored and

b) the considerably larger class size.

We would therefore ask to add 1 hour of tutorial to increase teacher/student contact and to reduce the lab attendance by 1 hour.

This would also bring the distribution of hours in line with Fr. 101.

<u>Cost</u>: Depending on number of groups, a semester maximum of 3 Language Instructor Base Units.
