Attached is a request from the Centre for Canadian Studies for a change in the credit-hour value for CN.S 400/401 from five (5) credit-hours to three (3) credit hours, effective in September, 1980 (80-3). The Universities Council of B.C. has approved the new Canadian Studies curriculum, which is based on a pattern of 3-hour courses at both the upper and lower division level. However, it appears now that the new program may not be put into effect until May 1981, for budgetary reasons.

In order to fit the work of students currently in the program to the new pattern of courses, the Centre for Canadian Studies has planned and scheduled all of its upper division courses from Fall 1980 on as 3-hour courses. To accommodate this pattern before the new program takes effect, it is necessary to drop the credithour rating for the currently used CN.S 400/401 courses from 5 hours to 3 hours.
