I saio 95 - ALTERNATIVE PROGRAMS WITHIN P.D.P.

Background:

Over the past several years the Professional Development Program has been characterized by innovative and important alternatives e.g., the Open Education Alternative (Masserman, Zola), Hastings Street (Trivett, Dawson), Burneby Secondary. However, except for the Open Education Alternative none of the programs listed above have operated continuously over the past three years. Since the Professional Development Program indicated that alternative programs are important options (P.P.C. - November 5, 1979), it is necessary to have guidelines to respond to proposals for alternatives that reflect faculty interests, student interests, and institutional requests.

At a previous P.P.C. Meeting (November 5, 1979) alternative programs were categorized into three types:

- a) specialized programs (within the pre-service, certification route),
- b) teacher upgrading (extension) and retraining programs,
- c) programs for those performing instructional roles outside the public school system.

After discussion of these types of programs, it was the general feeling of P.P.C. that at present any development of alternatives in P.B.A. he the focus on the first two types of programs.

Receptioning Lans:

- 5.1 The following guidelines be established in considering alternatives in P.D.P.:
 - a) That the Spring semester intake normally will provide the focus for offering alternative programs.
 - b) That academic and administrative support is deemed to be feasible before an alternative is implemented so as to ensure appropriate academic content, organizational planning, staffing, special placements, budget and facilities.
 - c) Any alternative program is subject to review on an on-going basis.
 - Any new alternative programs must be approved by the meeting of the Faculty of Education.
- 5.2 Approval for alternatives: 1980-81 academic year (subject to the recommendations approved in 5.1)
 - a) The Open Education Alternative continue to operate.
 - A Secondary Alternative Program continue to operate in conjunction with the Burnaby School District.
- 5.3 Approval for investigation, planning and possible implementation of Alternatives:
 - a) An Environmental Education Program.
 - A special focus module on multiculturalism (or another curriculum area). This may incorporate a focus on native programs.
 - A revitalized Education 406 program to emphasize extension or retraining for certified teachers.
 - d) A French immersion program.
 - A teacher education program focussing on an international student teacher clientele.
 - f) A certification program for teachers (1 module) working in independent schools be piloted (subject to Ministry sanction, see P.P.C. Minutes November 5, 1979).
 - g) An integrated campus 401/402 program for elementary students (maximum of three modules) be piloted. The integrated programs might focus on selected curriculum areas e.g., Reading/Language Arts, Multiculturalism, P.E., etc.

EDUC 406-0

Supervised Teaching-Observation and teaching in a public school for a minimum of 20 days under the supervision of a classroom teacher and a university instructor. The course is designed to offer ex-teachers planning to return to the classroom or teachers from other countries, an opportunity to familiarize themselves with current curriculum and methods of instruction in the public schools of British Columbia.

Perrequisites: EDUC 401 or equivalent and permission of Director of Professional Programs. Permission normally will not be given to students without previous teaching experience.

Grading will be on a Pass/ Withdraw basis.

For the purpose of calculating fees, this will be considered the equivalent of a 4 semester hour course.
