CURRICULUM CHANGES

Action undertaken by the Senate Committee on Undergraduate Studies at its meeting of March 10, 1981 gives rise to the following motion:

MOTION: That Senate approve and recommend approval to the Board of Governors, as set forth in S.81- ,

- the lower division course requirements specified for those who will undertake a Major or Honors or Minor in Economics and for those who will undertake a Joint Major or Joint Honors in Business Administration and Economics;
- ii) the upper division requirements for a Major and requirements for Honors in Economics, and for a Joint Major or for a Joint Honors in Business Administration and Economics.
- iii) The changes in prerequisites and in the use of some courses:

BUS. 372-3 - Micro Perspectives and Organizations

BUS. 374-3 - Macro Perspectives on Organizations

BUS. 481-3 - Personnel Management I: Manpower Planning and Staffing Decisions

BUS. 482-3 - Personnel Management II: Reward Systems and Employee Development

BUS. 472-3 - Seminar in Organizational Behavior

BUS. 488-3 - Human Relations in Business

BUS. 489-3 - Small Groups and Organizations

A number of revisions recently were approved by Senate relating to the programs in Business Administration primarily. The majority of the present changes are technical, following from the earlier actions but in some instances requiring formal approval now by Senate and the Board. Adjustments were required in particular to the Joint Major and Joint Honors requirements in Business Administration and Economics.

Upper Division Requirements

Normally, students will not be permitted to enter the Department's upper division courses (courses numbered 300 and 400) during their first 60 semester hours (with the exception of BUEC 332-3 and BUEC 333-3) without permission of the Chairman of the Department of Economics.

Normally, Majors will be expected to include 45 semester hours of upper division credit in their last 60 semester hours of work toward the degree.

Dear Mr. Evans:

As you requested, I have outlined in the statements below our intentions for the Prerequisites and Special Instructions for BUS. 372-3 and 374-3, for BUS. 481-3 and 482-3, and for BUS. 472-3, 488-3, and 489-3. After I left your office, I again spoke with Professor Hoyt and we thank you for your understanding--of our desire that in each instance the calendar language should reflect accurately our intentions and our concern that the 81-82 calendar, the first to carry the extensive changes in our programs, should be as precise as possible.

Calendar course names, numbers, and descriptions remain unchanged, and I have not needlessly repeated this material. I have noted only the specific language we wish to have substituted for the instructions that are listed at present:

BUS. 372-3 to read: Prerequisites: BUS. 270-3 (formerly COMM 270-3) or permission of

the Department; 60 credit hours.

Students with credit for BUS. 371-3 (formerly COMM 371-3) may take

one only of either BUS. 372 or BUS. 374 for additional credit.

BUS. 374-3 to read: Prerequisites: BUS. 270-3 (formerly COMM 270-3) or permission of

the Department; 60 credit hours.

Students with credit for BUS. 371-3 (formerly COMM 371-3) may take

one only of either BUS. 372 or BUS. 374 for additional credit.

BUS. 481-3 to read: Prerequisites: BUS. 372-3 and BUEC 332-3 (formerly ECON/COMM

332-3); 60 credit hours.

Students with credit for BUS. 387-3 (formerly COMM 387-3) may take one only of either BUS. 481 or BUS. 482 for additional

credit.

BUS. 482-3 to read: Prerequisites: BUS. 372-3; 60 credit hours.

Students with credit for BUS. 387-3 (formerly COMM 387-3) may

take one only of either BUS. 481 or BUS. 482 for additional credit.

BUS. 472-3 to read: Prerequisites: any one of BUS. 371-3 (formerly COMM 371-3),

BUS. 372-3, BUS. 374-3, or BUS. 387-3 (formerly
