The following Management and Systems Science curriculum changes are required because of curriculum changes made by the Departments of Economics and Business Administration. These changes should be incorporated into the 1982/83 edition of the University Calendar.

- I. Lower Division requirements: (see page 420 of current calendar)
  - A. Business Administration
    - -delete BUS. 103-3 Business in Society. This course has been changed to BUS. 303 and cannot, therefore, be considered a lower division requirement.
    - -add:
      Any 100 division ECON course.
  - B. Economics
    - -Calendar currently lists:
      - -- Any 100 division ECON course, or BUS. 103-3.
    - -delete BUS. 103-3 for same reason as stated in I. A.

## II. Upper Division Requirements

A. BUS. 371-3 Organizational Theory, and BUS. 373-5 Operations Management have been dropped from the curriculum and been replaced with the following:

## BUS. 372-3 - Micro Perspectives on Organizations

This course will examine models and concepts which are used to understand individuals and small groups in organizational settings. It explores issues of motivation, group and intergroup dynamics, leadership, communication, decision making, organizational climate, and organizational effectiveness.

(Lecture/Tutorial)

BUS. 270-3 (formerly COMM 370-3) or permission of the Department; 60 credit hours.

Students with credit for BUS. 371-3 (formerly COMM 371-3) may take one only of either BUS. 372 or BUS. 374 for additional

credit.

### BUS. 374-3 - Macro Perspectives on Organizations

This course will examine theories of organization which use the organization as a basic unit of analysis. It will show the structure and internal processes of an organization are linked to and partially determined by forces in the external environment of the organization. Contextual factors such as the technology and corporate strategy of the organization will also be examined. (Lecture/Tutorial)

Prerequisites: BUS. 270-3 (formerly COMM 370-3) or permission of the Department; 60 credit hours.

Students with credit for BUS. 371-3 (formerly COMM 371-3) may take one only of either BUS. 372 or BUS 374 for additional credit.

Therefore, BUS. 372-3 and 374-3 should replace BUS. 371-3 and 373-5.
