## MEMORANDUM

To SENATE

From Senate Committee on Undergraduate Studies

Kinesiology Credit for FPA.120-3,220-3,  
Subject 324-3, and 326-3

Date 20th July, 1976

Action taken by the Senate Committee on Undergraduate Studies at its meeting of July 13th, 1976 gives rise to the following Motion:

### MOTION:

That Senate approve, and recommend approval by the Board of Governors, the awarding of credit for the Kinesiology major or minor for FPA.120-3, 220-3, 324-3, and 326-3 as if they were Kinesiology courses, as set forth in S76-96.

NOTE - The four FPA courses identified above were formerly Kinesiology 144,244,310 and 344. With the approval of the new dance courses in Fine and Performing Arts these four Kinesiology courses have been, in effect, transferred from Kinesiology to Fine and Performing Arts. The transfer was clearly desirable for integrating the various arts in one program. However, the Kinesiology Department does not wish thereby to narrow the focus of its curriculum.

The original recommendation from the Kinesiology Department specified only credit toward a minor in Kinesiology. It was the understanding of members of the Senate Committee on Undergraduate Studies that the intent was to provide credit toward either a major or a minor and the Motion was amended to provide that approval subject to confirmation by the Department that this was their intent. Such confirmation has been received.



To implement the changes in our undergraduate minor consequent to the transfer of Kinesiology courses to Fine and Performing Arts (see ISC 76-10 to 76-16), we request that the Faculty Undergraduate Curriculum Committee approve the following:


