At its meeting of September 8, 1975, Senate considered the report of the Senate Committee on Committees (Paper S.75-120), approved many of the recommendations, but postponed discussion on the Senate Committee on Academic Planning and on the Senate Committee on University Budget, with referral to SCOC, as follows:-

(Moved by J. Hutchinson, seconded by R. Debo)

"That consideration be postponed until the October meeting, and the Committee on Committees be charged to further discuss the question of academic planning and the relationships with the Universities Council, ascertaining its committee structure, and present an informed paper to Senate at its October meeting."

The Chairman of Senate indicated that she would make available to Senate, and to SCOC, information on the structure of the committees of the Universities Council, the memberships, the terms of reference insofar as these are known. It was also agreed that data would be obtained from the University of British Columbia and from the University of Victoria concerning any developments or actions undertaken at those institutions as they pertain generally to these topics. The data was provided to SCOC and is now provided to Senate as Attachment II.

Appendix J - University of Victoria Response to Universities Council Actions The Committee on Committees also received written submissions from a number of Senators following the last Senate meeting and gave consideration to these in its further discussions.

To ensure that there was clear understanding of the motion for referral the mover, Senator Hutchinson, was invited to meet with the Committee to provide additional information and clarification and his contributions were very helpful and appreciated.

As a result of the additional discussions the Committee has made some changes to its earlier recommendations covering the Senate Committee on Academic Planning and the interrelated Senate Committee on University Budget. It considered with some care the problems of committee effectiveness, size, composition, input, terms of reference. It has assessed arguments for more lay Senators, student Senator, other Senators, general input whilst recognizing the difficulties of oversize. In particular it strives to accommodate the need for effective interrelationship between the SCAP, SCUB, and related bodies. As a principle it stresses some simplicity of organization/structure/terms of reference at this time to accomplish maximum effectiveness/flexibility/response as the various agencies respond to the charges expected to go to them. It accepts that the writing of further terms and clauses can be undertaken better following further development and experience.

It recognizes that the important matter of long-term planning is a complex and vexatious one and that the present proposals may be deficient in this particular area but it has not found fully satisfactory alternative solutions to offer now. Again experience with the proposed new committees may lead to useful proposals in the future. It is satisfied that adoption of the present recommendations need not, and indeed would not, inhibit appropriate revisions or additions should these become clear through the workings of the committee. A further committee, possibly drawing on the memberships of the present proposals, may be required but it is felt that this should not be entered upon without the next stage of experience.

It is in this vein that its earlier and present recommendations have been cast. Its recommendations for the Senate Committee on Academic Planning and for the Senate Committee on University Budget are given in Attachment I.

HTTACHMENT

SENATE COMMITTEE ON ACADEMIC PLANNING

(General Comment: The Academic Planning Committee has been a Presidential Committee. It is proposed that it become a Senate Committee, that there be some change in membership and some change in terms of reference. It is further proposed that it will have some interrelationship through membership on the proposed Senate Committee on University Budget.

It is also proposed that the terms of office of the elected Senators will be for two years, with staggered terms. In the first elections five shall be elected for two year terms to September 30, 1977 and four shall be elected for two year terms to September 30, 1976. To provide for staggered terms those five individuals with the highest number of votes shall be elected to September 30, 1977 provided they include at least one lay Senator and one student Senator, and the four individuals with the next higher number of votes shall be elected to September 30, 1976 provided they include at least one lay Senator and one student Senator.)

SENATE COMMITTEE ON UNIVERSITY BUDGET

(General Comment: It is proposed that this Committee be formed to consist of the nine Senators who are elected by and from Senate to the Senate Committee on Academic Planning, and it is further proposed that the terms of office be the same as for the terms on the Senate Committee on Academic Planning. It is also proposed that the Director of Institutional Studies act as Secretary, non-voting, the same as is proposed for the Senate Committee on Academic Planning.

It is recommended that the Chairman be elected by and from the voting members of the Committee; and that the term of reference be as extracted directly from the Universities Act.)

Senate requested at its meeting on September 8, that I provide members with further details about the powers and operation of the Universities Council.

With respect to the powers of Council, I refer members to Section 70 of the Universities Act (1974) entitled "Powers" and also to Section 71, entitled "Limitation on powers" (attached as appendix A).

As to the operations of the Council, up to now these have related chiefly to examining the operating and capital budget requests of the three universities and to setting up the following committees. The first two committees have each met twice and the remaining committees have each met once.

- 1. Business Affairs Committee The terms of reference and membership are attached as Appendix B. In response to the Council's request for three or more nominees from which the Council would choose one, we have submitted our nominees, but the Council has decided not to select a representative at this time. However, Mr. G. Paulson, Comptroller, attends these meetings as an observer, and the other two universities also have observers in attendance.
- 2. <u>Capital Planning and Development Committee</u> The terms of reference and membership are attached as Appendix C.
- 3. <u>Graduate Studies and Research Committee</u> Originally, these were divided into two separate committees, with separate terms of reference. The combined terms of reference for the single committee are not yet available from the Council, but the combined membership is attached as Appendix D.
- 4. Programme Co-ordinating Committee The updated membership list is not yet available from the Council, but the Council has selected Dr. B.G. Wilson and Dr. R. Brown as our representatives. For general information, the membership list of June 30, 1975, is attached, as well as the terms of reference, as Appendix E.
- 5. Ad Hoc Committee on Extension and Continuing Studies The Council has just selected Dr. R. Carlson as our nominee. The terms of reference and membership are attached as Appendix F.
- 6. Ad Hoc Committee on Data Collection The terms of reference and membership are attached as Appendix G.

Since reference was made to some non-Council Committees, I should mention the B.C. Post-Secondary Co-Ordinating Committee, which operates under the Department of Education, and which replaces the Academic Board. This is an interim Committee which is scheduled to sit until January 1, 1976. The Terms of reference and membership are attached as Appendix H.

Appendix A

(2) The Universities Council may, subject to the *Public Service Act*, designate the title, office, and responsibilities of any employee of the Universities Council.

(3) The Lieutenant-Governor in Council may, by order, declare that some or all of the provisions of the *Public Service Superannuation Act* apply to the executive director and some or all of the other employees of the Executive Council, and that Act applies accordingly.

(4) The Universities Council may, notwithstanding the *Public Service Act*, with the approval of the minister, engage and retain such persons as it considers necessary as consultants, experts, or specialists, and may fix their remuneration.

68. Except as provided in this Part, the *Companies Act* does not apply to the Universities Council, but the Lieutenant-Governor in Council may, by order, direct that the *Companies Act* or any provision thereof applies to the Universities Council and, thereupon, that provision applies to the Universities Council.

69. (1) No member or employee of the Universities Council and no

person acting under the authority of this Part or the Universities Council is personally liable for any loss or damage suffered by any person by reason of anything in good faith done or omitted to be done in the exer-

70. The Universities Council has power

- (a) to provide for the regulation and conduct of its meetings and proceedings;
- (b) to carry out studies or research projects related to matters within its jurisdiction;
- (c) to require the universities to prepare and forward to the Universities Council plans for the short-term and long-term academic development of the universities, approved by the senate and by the board before being forwarded to the Universities Council;
- (d) to advise the Government of the Province respecting the establishment of new universities;
- (e) to approve the establishment of new faculties and new degree programmes;
- (f) to receive, review, and co-ordinate the budget requests presented to it annually by the universities or presented at any other time at the request of the Universities Council; to transmit its recommendations together with the original proposals from the universities

to the minister; and to receive, allocate, and distribute capital and operating funds and any other money allocated by the Government of the Province or of Canada for the support of the universities; but a university is not required to use the capital or operating funds allocated to a university for any particular aspect of its operations;

(g) to require the universities to consult with each other on actions which might be taken to minimize unnecessary duplication of faculties and programmes of study;

- (h) to make recommendations to the universities on any matter;
- (i) in consultation with the universities, to establish standards for various categories of university buildings so as to provide a basis upon which the Universities Council may assess university requests for total capital expenditures, and, in consultation with the universities, to review these standards from time to time;
- (j) to require the universities to provide the Universities Council with whatever reports and other information the Universities Council may require to carry out its powers under this Act;
- (k) to require a university to establish such accounting and information systems as the Universities Council considers necessary for the proper conduct of the business affairs of the university;
- (1) to consult with the universities in an effort to co-ordinate their solicitation of moneys for research;
- (m) to receive proposals from the public respecting new programmes, institutes, and like matters;
- (n) to consider matters respecting student aid and fees;
- (o) to establish evaluation procedures for departments, faculties, programmes, and institutes;
- (p) to establish such committees representative of the Universities Council and the universities as the Universities Council considers necessary or advisable, but in particular
 - a business affairs committee, the purpose of which is to advise the Universities Council on financial matters affecting the budgets of the universities;
 - (ii) a programme co-ordinating committee, the purpose of which is to advise the Universities Council on all matters relating to undergraduate programmes;
 - (iii) a graduate studies and research committee, the purpose of which is to rationalize all matters respecting post-graduate programmes and research in the universities; and
 - (iv) a capital planning and development committee, the purpose of which is to review and advise the Universities Council on all matters having to do with capital expenditures of or for the universities;

- (q) to gather and make available to the universities information relevant to university education in the Province to assist in planning and development;
- (r) generally, to inquire into the financial requirements of universities and advise the minister of the sums of money required for the support and development of each university and universities generally; and
- (s) generally, to act as an intermediary between the Government of the Province and the universities, and between the respective universities, for the purposes of this section.

71. Notwithstanding section 70, the Universities Council shall not interfere in the exercise of powers conferred on a university, its board, senate, and other constituent bodies by this Act respecting

(a) the formulation and adoption of academic policies and standards;

(b) the establishment of standards for admission and graduation; and

(c) the selection and appointment of staff.

72. (1) The Universities Council shall endeavour to hold its meetings in public at locations throughout the Province in which interested members of the public will be encouraged to express their views and concerns respecting the matters under consideration by the Universities Council.

(2) Nothing in subsection (1) shall be construed or interpreted in such a manner as to restrict the right of the Universities Court il to conduct its proceedings in camera where, in its opinion, the public interest so requires.

73. For the purposes of this Part, the Universities Council may, subject to the approval of the minister, enter into such agreements as the Universities Council considers advisable with

- (a) the Government of Canada; or
- (b) a municipality; or
- (c) a regional district; or
- (d) an agent of the Crown in right of the Province or of Canada; or
- (e) any department of a Provincial or the Federal Government; or
- (f) any person or association.

In response to the new Universities Act, the Senate of the University of British Columbia has established a Senate Advisory Committee on the budget. The Committee's terms of reference are the same as those identified in the Universities Act with the Committee itself composed of six senators. In practice, the same operating budget procedures that existed before the establishment of the Committee have been followed. The one addition has been that after the President has met with the Vice-Presidents and Deans regarding their operating budget requests, he then met with the Senate Advisory Committee on the budget to give them an opportunity to ask questions about the requests that have been submitted and the rationale for the inclusion or exclusion of either certain items on the budget or the amounts requested for those items contained in the budget. Following this discussion with the Committee, the President has then met again with the Deans and Vice-Presidents resulting in some revisions to the budget proposal in line with the suggestions emanating from the Senate Advisory Committee.

There also exists a Senate Committee on Academi. Building needs. However, this Senate Committee was established prior to the existence of the Universities Council and has not yet been modified in any way as a result of the establishment by the Universities Council of its Capital Planning and Development Committee. Under its existing terms of reference, the Senate Committee on Academic Building Needs does not get into the cost implications of individual new buildings although the possibility exists that its terms of reference may be revised to give it this responsibility as well.

U.B.C. does not have an Academic Planning Committee. Rather, requests for new programs and/or modifications to existing programs emanate within departments and Faculties and are forwarded directly to Senate for their consideration.

Regarding nominations and appointments to University Council committees, most of these were made by former President Gage.

Regarding the internal organizational structure of the University of British Columbia, responsibilities among the four Vice-Presidents have been allocated as follows:

- Vice-President Shaw has now been assigned the responsibilities formerly held by Deputy President Armstrong. In addition, he has overall responsibility for planning, development and co-ordination of academic affairs and such physical space requirements as relate to the academic purposes of the University.
- b) Vice-President Voigt has responsibility for the ongoing improvement of Student Services including such matters as the Bookstore, Athletics, Residences etc. He also has responsibility for those faculty affairs that relate directly to promotion and tenure.
- c) Vice-President Connaghan has responsibility for the non-academic sector of the University including such activities as information services, traffic and control, campus mail, personnel, purchasing, physical plant, etc.

Vice-President White - has responsibility for the financial affairs of the University and will also continue to serve as Secretary to the Board of Governors.


Subject UNIVERSITY OF VICTORIA RESPONSE TO UNIVERSITIES COUNCIL ACTIONS

Date SEPTEMBER 11, 1975

In response to the new Universities Act, the Senate of the University of Victoria has established a Senate Advisory Committee on the Budget. The Committee's terms of reference differ from those established in the Universities Act in the sense that the Committee is advisory to the President on both the operating and capital budget proposals.

There also exists a Senate Campus Planning Committee. However, this Senate Committee was established prior to the existence of the Universities Council and has not yet been modified in any way as a result of the establishment by the Universities Council of its Capital Planning and Development Committee. There has also existed prior to the establishment of the Universities Council and the new Universities Act, an Academic Planning Committee at the University. At present consideration is being given in Senate to a new planning structure which would call for a new planning committee whose terms of reference would include academic planning and certain aspects of physical planning, particularly those that relate to academic priorities. The existing Academic Planning Committee would be abolished while the Campus Planning Committee would become an advisory committee to the President. The responsibilities of the Campus Planning Committee would then become to review and establish priorities on all physical plant additions throughout the University taking into consideration the cost implications of each project.

Regarding nominations to Universities Council committees, the University of Victoria did not make nominations to all of the committees identified by Mr. Armstrong. Rather, they made nominations to those committees where they were clear as to the terms of reference and where they felt that the University of Victoria had a significant contribution to make. Where nominations were made, no choice was given to the Chairman of the Universities Council. Rather, the University itself determined who would be the most appropriate person to sit on the specific committee involved and made a recommendation accordingly. In large measure, the appointments made to the Universities Council committees consisted of the administrative officers of the University.
