At its meeting of 12th November, the Senate Committee on Undergraduate Studies considered the attached proposal for EDUC.483-8: Curriculum Studies.

It was emphasized that this course would provide the Faculty of Education and its students with increased flexibility in offering major courses in curriculum studies, a flexibility which does not now exist with the current courses, EDUC.485-15 and EDUC.484-8. The new course will be offered most often during the Summer semester to provide practising teachers with an opportunity to undertake work for a two month period, but it will also occasionally be offered during the Fall and Spring semesters. It should be noted that EDUC.485-15: Curriculum Studies will be dropped from the Curriculum if this course is approved.

This proposal is now forwarded to Senate for its consideration, with the Committee's recommendation that it be approved. It is also recommended that, should the course be approved, the normal two semester time-lag requirement be waived in order that the course may first be offered during the Summer, 1975.

1. Calendar Information

Department: Education

Title of Course: Curriculum Studies

Calendar Description of Course: Development of conceptual and technical skills through workshops, seminars and directed and independent study. The course will deal with human development and learning in the school. Stress will be placed on approaches to individualizing instruction and integrating the curriculum in different subject areas. It will normally be taught by two or more faculty members.

Nature of Course: Workshops, Seminars and Directed and Independent Study

Prerequisites (or special instructions): EDUC. 401 and EDUC. 402

What course (courses), if any, is being dropped from the calendar if this course is approved: EDUC. 485-15

Rationale: Curriculum Studies (EDUC. 485-15) currently consists of a full 15 semester hour program in the types of activities described above in #1. Curriculum Studies (EDUC. 484-8) currently constitutes the taking of 1/2 of the 485-15 program in the sense that students participate in required activities for only 2 months, rather than the full semester. Many students have expressed the ideas that the completion of 484-8 is insufficient for their needs and they wish to continue the Curriculum Studies program for an additional 2 months (or the equivalent of 485). This is particularly true of practicing teachers who can attend only in the July-August portion of the semester.

3. Objectives of the Course

a) To increase understanding of the concepts and principles underlying education, particularly in the areas of curriculum development, human growth and development, and human interaction.

- b) To achieve competencies related to
 - i) developing and evaluating curriculumomaterials
 - ii) promoting and assessing learning
 - iii) observing, diagnosing and remediating learning difficulties
 - iv) developing and analyzing interaction strategies
 - v) increasing experience in self-directed inquiry based upon choices relevant to one's own professional needs and goals
 - vi) furthering acquaintance with the literature on teaching and learning

Major Topics

- 1. Goals and objectives of education in general and of curriculum and teaching in specific and interrelated areas
- 2. Human interaction and curriculum development
- 3. Resources for curriculum development: people, space, materials, equipment, budget
- 4. Integration of curriculum areas
- 5. Scope, and sequence of content or subject matter in curriculum areas
- 6. Teaching learning strategies appropriate to human growth and development and congruent with defined objectives
- 7. Guidelines for materials analysis
- 8. Evaluation of learning outcomes and materials used in terms of goals and objectives
- 9. Redesigning curriculum

Proposed Course in Relation to Undergraduate Courses and Programs

The proposed course EDUC. 483-08 replaces EDUC. 485-15. It affords greater flexibility for students who, unable to attend for a full semester, may study curriculum in depth for two sessions (Inter Session and Summer Session).

Overlap with Other Courses

There is overlap between EDUC. 483-08 Curriculum Studies and the individual curriculum courses in the Designs for Learning series EDUC. 472-04 through EDUC. 479-04. The overlap is desirable in that it affords an opportunity to view curriculum as a whole and/or in terms of its parts.

There is no undesirable overlap between the objectives and content of EDUC. 483-08 and the objectives and content of other courses existing in the University.
