## Calendar Changes

# DEPARTMENT OF ARCHAEOLOGY

At its meeting of October 12, 1971, the Faculty of Arts Curriculum Committee approved the 1972-73 Undergraduate Calendar Submission for the Department of Archaeology.

The change include one new course, ARCH 301 and two courses numbered 373 and 385 which are sub-divisions of the present Fossil Man course. In view of the wide range of interests in Fossil Man, the Archaeology Curriculum Committee considers it highly desirable that this course be separated into two courses, a lecture course and a laboratory course.

Brief descriptions of these courses are outlined below.

ARCHAEOLOGY 301-2 Prehistoric and Primitive Art

Art styles and traditions of prehistoric and preliterate peoples. (2-0-0)

Prerequisite: Any lower division Archaeology course.

ARCHAEOLOGY 373-4 Human Osteology

A detailed study of the human skeleton, with emphasis on lab and field techniques. (0-0-6)

Prerequisite: Any lower division Archaeology course or permission of the instructor.

ARCHAEOLOGY 385-3 Fossil Man

The relationship between culture and biology in the prehistoric evaluation of man. The recognition and critical evaluation of the significance of the similarities and differences among fossil human types.

(3-0-0)

Prerequisite: Arch. 272





No similar course is offered in the University. The subject is introduced in lower level Archaeology courses, but is nowhere covered in depth.

Aboriginal art of North America, Africa, Oceania, Australia and Asia;
Paleolithic and Neolithic art; Art as an expression of belief systems;
recognitions and analysis of art styles; Art as an aid in reconstructing prehistoric cultures.

Archaeologists are expected to have a general knowledge of primitive art. Other students are very much interested in this subject.

#### 3. JUSTIFICATION

A. What is the detailed description of the course including differentiation from lower level courses, from similar courses in the same department, and from courses in other departments in the University?

Detailed study of the human skeleton.

There is no such course offered in the University

B. What is the range of topics that may be dealt with in the course?

Detailed landmarks of the various bones of the skeleton; techniques and methods for identifying the sex, age, race, stature, etc., of individual skeletons; recognition of pathological manifestations; the reconstruction of fragmented skeletons.

- C. How does this course fit the goals of the department?

  The course helps to fulfill the expected range of knowledge for the professional archaeologist who must be able to recognize and identify the human skeletal evidence so often associated with the cultural data he is researching.
- D. How does this course affect degree requirements?

  The course is not required of majors, but is highly recommended
- E. What are the calendar changes necessary to reflect the addition of this course?

Addition of the course to the calendar.

Deletion of Arc. 375-5.

F. What course, if any, is being dropped from the calendar if this course is approved?

This course is an expansion and separation of the laboratory portion of the existing Fossil Man (375) course. Separation of the lab from the lecture section permits students with only a general interest to take that course, and students with more specific interests to take them both.

- G. What is the nature of student demand for this course?

  The demand for this course among students majoring in archaeological studies is universal.
- H. Other reasons for introducing the course.

Degree recipients in the Department must compete with other professionals who have routinely included in their background a knowledge of human osteology. This course will help our graduates to compete on a more equal basis.
