APPENDIX 5A

3.7 Audit Student:

۰,

A student granted admission and officially registered for "audit" in a course or courses, but not for credit or grades. The student normally must have fulfilled requirements for admission as set forth in University regulations for one of the other categories of registration.

(a) A student not formally registered as a regular, or qualifying or special student, but taking one or more courses for "audit" without credit or grades will be registered as an "audit student". Application for admission and registration will follow the general University regulations pertaining to other students.

(b) If a student is admitted and registered at the commencement of a semester as a regular, or qualifying, or special student, the student with approval of the instructor of the course or courses concerned may also officially register at that time for one or more courses for "audit". A student registered for "audit" who has fulfilled requirements expected by the instructor will have "audit" entered on his record, but without official credit towards degrees or other qualifications.

A student who, in the opinion of the instructor, does not fulfill requirements for "audit" will not have entry made on records and the courses being audited will be deleted.

Fees for "audit" appear in the University Calendar.

Note that persons duly registered for credit courses may be encouraged to attend other courses for which they are not formally registered but permission to attend rests with the instructor of the course concerned. No entry of attendance will appear on the official record of the Registrar or on transcripts of record.

- Dr. J. Koepke submitted a motion outlining some controls governing graduate courses for "audit" recognition. There was some disagreement on the committee and the Secretary was requested to prepare a paper incorporating the intent of Dr. Koepke's motion. This paper was discussed by the Executive Committee and there was disagreement as to whether there should be, or should not be, authorization for students to undertake graduate courses for "audit" recognition. The paper prepared by the Secretary was distributed with enquiry to the Graduate Studies Committees of the faculties.
- 2) Responses have been received from the Faculty of Arts Graduate Studies Committee, and from the Faculty of Science Graduate Studies Committee. No response has yet been received from the Faculty of Education Graduate Studies Committee.
- 'Copies of the responses are attached. It will be noted that:-
 - (a) the Faculty of Arts Graduate Studies Committee voted 4 to 1 to have graduate courses for "audit" recognition and 5 to 0 in support of the control paper which was distributed.
 - (b) the Faculty of Science Graduate Studies Committee was unanimous in its decision that there should not be provision for formal "audit" recognition in graduate courses.
- 3) Decision will be required as to whether or not graduate courses may receive formal "audit" recognition.
 - Note: Attached as "Appendix 5" is a copy of the paper as originally submitted to the Executive Committee. Also attached as "Appendix 5A" is a copy of the paper as modified in discussions at an earlier meeting of the committee.
- 4) The following motions were presented at the Executive Committee meeting of July 7:-

Moved by K.Rieckhoff, seconded by R.Harper that,

"the concept of auditing of graduate courses be deleted from the General Regulations of Graduate Studies."

Moved by M.McClaren, seconded by D.Baird that,

"the motion be tabled pending discussion by the representatives of the three faculties on the question of auditing per se in regards to get studies."
