Subject Graduate Regulations	Date 26 September 1975

I recommend that the Cummulative Grade Point Average (CGPA) as defined in section 5.1 be redefined as the average of all graduate courses accepted toward a Master's or Doctoral degree.

Undergraduate courses may not be applied against the minimum coursework requirements, so they should not be used to calculate the CGPA which is used (section 5.3) as the criterion for continuation and graduation.
