- 1. APPROVAL OF MINUTES

- 3. SUBMISSIONS FOR THE CALENDAR

- 4. FACULTY OF SCIENCE REGULATIONS deferred until discussion of 5. and 6.
- 5. CENERAL REGULATIONS FOR THE CALENDAR ADMISSIONS

J. Ellis presented this document, which had been approved by Joint Faculty. In discussion the following changes were made:

Page 1 - item 2., a), the word "completed" should be inserted before the word "application".

Page 1 - item 2., ii), to remain as in the present calendar, i.e. "A student is responsible for the completeness and accuracy of his application".

Page 4 - item 3. heading, to read "Admission of Secondary School Students Who Have Not Completed Grade XII", and in the first line insert "or XII" after "XI".

Page 4 - change item B. c) to read "two letters of reference from close acquaintenances competent to assess the applicant's ability to proceed with university studies".

Page 5 - item C., add to the second santance "except with special permission from the Admissions Committee".

Page 5 - item C., the second sentence should end with the word "so" in the fourth line.

Page 5 - items D. and E., the word "equivalent" was changed to the . word "comparable".

Page 6 - item 3., penultimate line, the words "or for compassionate reasons" were inserted after the word "illness".

With the foregoing changes item 5. was approved.

6. GENERAL REGULATIONS FOR THE CALENDAR - EXAMINATIONS & SCHOLASTIC

the Item 5 was deleted from/recommendation by the Registrar. It was moved that item 5. replace item 6. The motion was defeated.

Item presently numbered 6. was then discussed and it was moved, seconded and agreed that paragraph c) be deleted and that paragraphs a), b), d) and e) be approved.

The Registrar pointed out that the last sentence in section 3., in brackets, had not been approved by joint faculty and requested that it now be approved. The members agreed to approve this sentence.

Standing and Credit

The Chairman reported that no agreement was reached at the joint meeting of faculty on grading and the matter was therefore referred back to the faculties and subsequent discussion by joint faculty, with the grading in the calendar to remain unaltered, with the substitution of D for T.

K. E. Rieckhoff then reported that the Faculty of Science proposed and advanced a four point scale and wished to go on record as supporting this.

This section was then passed as presented.

GENERAL REGULATIONS FOR THE CALENDAR - FACULTY OF SCIENCE

In presenting his paper Dr. Nelson pointed out that in view of the decisions reached on Examinations, Re-reading of Answer Papers, Standing and Credit, and Graduation; these sections were not germane to the present discussion. It was then agreed that since these sections had been passed for inclusion in the general section of the calendar they need not be included here.

It was further agreed that the first paragraph under General Regulations be deleted.

There was some objection to paragraph 4. under General Regulations, since it depended on the Faculty of Arts and had not been discussed. It was pointed out that there had been no opportunity to discuss this question and that this was an attempt to keep within the original intent. It was then agreed that this paragraph remain as presented and that it would be discussed between the faculties with a view to amending the statement in the next calendar.

With the foregoing changes item 4. was passed.

7. SUGGESTED STATEMENT ON STUDENT CONDUCT

8. CASE OF CYRIL MITCHELL

In view of the fact that there appeared to be insufficient items to justify a meeting at that date, it was moved, seconded and agreed that the date of the next meeting be left to the judgment of the Chairman, that notice of such meeting be given at least ten days in advance, and that the meeting be held on a Monday.

The meeting adjourned at 7:00 PM.
