  - 1. Paper S.74-74 Election Academic Planning Committee

MASC 411-6 - Comparative Embryology of Marine Invertebrates

MASC 412-6 - Biology of Fishes

J. Barlow pointed out that, due to an omission, the prerequisite statement for MASC 435-6 was incomplete, and it should read:

"Biology 204-3, Biology 306-3 or Biology 326-3. The normal Chemistry and Physics requirements for the BioScience program or their equivalents, must precede."

The Chairman stated that the prerequisite statement would be subsumed in the motion.

D. DeVoretz asked for the rationale for the additional prerequisites and J. Barlow responded that, as some Biology students tend to leave the Physics requirements until the end of their programs, the prerequisite would ensure the necessary preparation for enrolment in this course.
