On behalf of Senate, the Chair welcomed the following new Senators: M. Pinto, Vice-President Research; D. MacLean, Dean, Faculty of Health Sciences, and R. Blackman, Faculty of Arts.

1. Approval of the Agenda

The Agenda was approved as distributed.

2. <u>Approval of the Minutes of the Open Session of July 5, 2004</u> The Minutes were approved as distributed.

3. Business Arising from the Minutes

There was no business arising from the Minutes.

4. Report of the Chair

Referring to the recent announcement about the relocation of the Olympic speed skating oval from SFU to the City of Richmond, the Chair expressed his regret about the decision and about the process by which it was decided. The Chair reported that he has expressed disappointment to the Organizing Committee about their decision to forego SFU's very coherent and well-developed legacy plan for the long-term development and performance enhancement of athletes.

5,. Question Period

A question, submitted by S. Hunsdale, concerning the governance of the Great Northern Way Campus, particularly the lack of student representation on the Board of Trustees was directed to the President, and inquiry was made as to what efforts would be undertaken by the Administration to promote student representation on the Board. The Chair advised that no change was planned to the composition of the Board until such time as the Consortium decides to offer programs separate from those endorsed by the individual academic governing bodies of the partner institutions. At the present time there are no degree programs at GNWC. The Great Northern Way Campus is essentially a piece of property owned in equal shares by Consortium partners, and the Board - which has an administrative representative from each institution - manages the administration of that property. If at some point there were self-standing programs offered and administered by the Board rather than by governing bodies of the University, then the Administration would move to ensure that there was appropriate student representation.

6. Reports of Committees

A) Senate Nominating Committee

i) Paper S.04-54 – Elections

Senate was advised that no further nominations were received. Therefore, Peter Liljedahl was elected by acclamation to the Senate Appeals Board, and the Student Senator vacancies on the Senate Committee on Continuing Studies and the Senate Committee on International Activities would be carried forward.

- B) <u>Senate Committee on University Priorities</u>
- i) Paper S.04-55 Dissolution of the Centre for Systems Science

Moved by J. Waterhouse, seconded by I. Gordon

"that Senate approve and recommend to the Board of Governors the dissolution of the Centre for Systems Science (CSS), effective immediately"

Question was called, and a vote taken.

- ii) Paper S.04-56 Library External Review (For Information)
 Senate received the External Review of the Library for information. Congratulations were extended to L. Copeland, University Librarian and the Staff in the Library on the highly positive and excellent review.
- iii) Paper S.04-57 Burnaby Mountain University Professorships; Terms of Reference

Moved by J. Waterhouse, seconded by C. Apaak

"that Senate approve and recommend to the Board of Governors the terms of reference for the Burnaby Mountain University Professorships"

Question was called, and a vote taken.

iv) Paper S.04-58 – Farley Professorship in History; Terms of Reference

Moved by J. Waterhouse, seconded by J. Pierce

"that Senate approve and recommend to the Board of Governors the terms of reference for the Jack and Nancy Farley University Professorship in History"

Question arose as to why the terms of reference for this Professorship which has been in existence for quite some time were coming forward at this point. Senate was advised that in this case, as in the previous item and the next item, the Professorship/Chair was created prior to the adoption of policy that requires Senate to approve the terms of reference and these terms were being forwarded for approval at this time.

It was observed that there appeared to be an inconsistency between documents with respect to the substance of information provided. Senate was advised that the primary difference related to the details with respect to the method of appointment. Some of these details were redundant since the method of appointment for all positions was set out in University policy, but SCUP had directed that these policies should be referenced.

Suggestions by J. Pierce, P. Percival, and S. Hunsdale to change the first sentence of paragraph two to read: "The Farley Professor will be a scholar an established scholar of any rank whose scholarly achievements are clearly superior relative to others of that rank and who will" were accepted as friendly amendments.

Question was called, and a vote taken.

v) Paper S.04-59 – J.S. Woodsworth Chair in the Department of Humanities; Terms of Reference

Moved by J. Waterhouse, seconded by J. Pierce

"that Senate approve and recommend to the Board of Governors the terms of reference for the J.S. Woodsworth Chair in the Department of Humanities"

Question arose as to whether the terms of reference before Senate were changed in any way in response to the controversy surrounding the Woodsworth Chair. Senate was advised that the terms of reference were essentially those that were developed when the endowment was established and the fact that they were now before Senate was not directly related to any controversy surrounding that matter.

In keeping with existing policy, a suggestion by J. Pierce to change the first sentence of the second paragraph to read: "The individual who occupies the Chair will be a senior academic an established scholar whose scholarship", and a suggestion from E. Johansen to capitalize 'Member of Parliament' in the next sentence were accepted as friendly amendments.

Question was called, and a vote taken.
