Revision of Admission Requirements for Fall 2011 online calendar.

Effective: Fall 2011

Summary of Changes

1) The Undergraduate Department would like to add three World Literature 'W' courses to our Lower Division Requirement of English/Philosophy courses. These courses are WL 101W, WL 103W, and WL 104W.

Rationale

To provide more range of W courses for admission for internal and external students transferring to SFU Business, especially at the Surrey campus where Engl/Phil courses are limited.

2) The Undergraduate Department would also like to add Phil 001 back to the Business/Computing Science Joint Major.

Rationale

Phil 001 was removed from the list as an editorial mistake when Phil 100 and 120 were added back in 2005/2006. Phil 001 is not a W course; however adding Phil 001 is consistent with our other Joint Major and Major programs.

Calendar Change

Effective: <u>Fall 2011</u> online Calendar. The calendar changes are to be added to all Business programs (major, honours and joint majors/honours, and second degree) that require lower division requirements of 2 or 1 English/Philosophy. This change does not affect the Business Minor or SIAT/Bus Joint Major programs.

SCUS 11-15b

Calendar Change, Undergraduate Department, Faculty of Business Administration

Effective: Fall 2011 calendar

Within the majority of Business programs, students must take BUS 360W and at least two of the 400 level Business courses, including BUS 478, at SFU.

Rationale: University regulations state that the upper division writing intensive course must be done within the major program and must be completed at SFU. The above statement will emphasize this point.

As SFU is granting the degree, we believe that it is important the students complete at least 2 of the 400 level courses at SFU, including Bus 478. This change will need to be reflected in the SFU Calendar for Business programs.

The changes will affect these programs in various ways:

Minor

Under Upper Division Requirements

All upper division BUS courses have a prerequisite of 60 units but approved business administration minors may complete 300 division BUS courses upon completion of 45 units. However, any upper division BUS or BUEC course completed before 60 units will not count toward fulfilling the 16 upper division units for the minor. Students wishing to take Bus 360W-4 and Bus 478-3 to fulfil the 16 upper division requirement must take these courses at SFU.

Effective: Fall 2011 calendar

Management Science (MS) Concentration name change to Operations Management

Rationale: The name "management science" is dated and unsuitable as it does not reflect the specific skills and learning that our undergraduates specialize in. It is an inappropriately broad label for our teaching concentration. If we look at the journal Management Science which is the top outlet for scholarship in this area, it states that management science covers "all aspects of management related to strategy, entrepreneurship, innovation, information technology, and organizations as well as all functional areas of business, such as accounting, finance, marketing, and operations". The 300 and 400 level courses in the MS concentration focus only on the last functionality listed in this quote — operations management. Furthermore, by changing the concentration name to "operations management" it is more closely aligned with recognized careers and professions in supply chain management, logistics, service operations, and purchasing.
