Description:

Computers are becoming a fact of life for educators. The problem for teachers is to: a) gain the necessary computer literacy and, b) find a realistic method for implementing computer use in the classroom within the current financial constraints. Students in this course will: a) be able to confidently use a wide range of commercial educational software and understand computer operating systems; b) be able to teach computer literacy and program design to students using the computer language LOGO, c) be able to critically evaluate commercial software and select effective programs for classroom use; d) be able to operate "tool" programs (spreadsheet, word processing, and information filing) at a beginning level and have a sufficient understanding to continue self-education in these programs; e) be able to recognize the major BASIC language command words and develop an initial grounding in their use, and f) develop a critical awareness of the theoretical issues involved in the increasing use of computers in society.
