

SENATE SUMMARY

MEETING OF OCTOBER 7, 2013

1. **Report of the Chair**

The Chair reported that SFU maintained its position in the Times Higher Education (THE) World University Rankings in the 226th to 250th bracket and 13th in Canada. In the QS World University Rankings, SFU leapt 38 steps over the previous year to 244th in the world, 67th in North America and 12th in Canada.

The Chair reported on recent research accomplishments. Mark Collard of the Department of Archaeology, along with two SFU post-doctoral fellows, Jessica Munson and Jonathan Scholnick, are co-principal investigators on a three-year, \$829,000 project funded by the National Science Foundation and led by UC-Davis. Dugan O'Neil, Bernd Stelzer, and Michel Vetterli of the Department of Physics, are members of the international team receiving the 2013 European Physics Society prize for High-Energy Particle Physics for their discovery of the Higgs boson at CERN. SFU researchers collectively were awarded more than \$3.5 million in grants from SSHRC in the last Insight and Insight Development grants competition.

The Chair reported that, as President, he tabled his goals and objectives for the coming year with the Board of Governors and they have approved them. The President will focus on the issue of course access for students. The Chair reported on recent events including the SFU Public Square and the Truth and Reconciliation week. The Chair acknowledged individuals involved in the coordination of on-campus Week of Reconciliation activities: Clay Gray, a student who led the initiative from the student side; William Lindsay of the Office of Aboriginal Peoples and his staff, Nicole Rogers and Trina Isakson who served as project manager; and elder Margaret George, among many others who participated. The week included a well-attended event at the SFU Theatre, with speaker Karen Joseph and residential school survivors. The Walk for Reconciliation was held the following Sunday with a significant turnout, including the Minister of Advanced Education – an SFU alumnus. The Chair thanked Senate for their decision to encourage faculty members to accommodate students who participated in these initiatives, and noted that the University was able to provide a consciousness-raising, educational experience and the opportunity to participate in off-campus Week of Reconciliation events.

The Chair reported that convocation would be happening later that week and noted that this would be Kate Ross's last convocation and her last Senate meeting at SFU. The Chair expressed his appreciation on behalf of Senate for all that she has done for Senate and for the University.
