The SCA PBD orogram requires thirty upper division SCA redits. As some students may want to take sourses in more than one discipline, we offer flexibility in course selection for interested students. In some cases, orerequisite courses may be required. Placement is by AIP process (audition, interview or portfolio). If a current SFU student is interested in receiving the PBD, all course selections and agreement locuments are to be completed one year orior to graduation. The agreement locument will be completed by the SCA advisor and sent to the student and area coordinator listing selected courses for the PBD.
