## **Bachelor of Arts Program**

# FROM:

Students can meet the bachelor of arts (BA) requirements through one of the following five options: a major program, a joint major program, two extended minor programs, an extended minor program and a minor program, or two minor programs, at least one of which must be in the Faculty of Communication, Art and Technology (FCAT). Students who are interested in completing either two extended minors, or an extended minor and a minor program, or two minor programs must meet with an undergraduate advisor in one of the FCAT schools for academic advice and program approval.

# Bachelor of Arts with two minors; two extended minors; or a minor and extended minor

Students wishing to acquire knowledge in two program areas for the BA degree, but not desiring to undertake a major or a joint major program, may complete a program consisting of two extended minors, an extended minor and a minor, or two minors, at least one of which must be in the Faculty of Communication, Art and Technology. Students who are interested in this option must meet with a faculty advisor in one of the FCAT schools for academic advising and program approval.

### For all bachelor of arts options, as noted above, at least 120 units are required, which include completion of

at least 60 units completed at Simon Fraser University

at least 45 upper division units, of which at least 30 must be completed at Simon Fraser University satisfaction of the writing, quantitative and breadth requirements of the University. Students who complete a joint major, or two extended minors, or an extended minor and a minor, or two minors, may fulfill the breadth requirements in either one or both of their chosen program areas.

Students wishing to acquire knowledge in two program areas for the Bachelor of Arts (BA) degree, but not desiring to undertake a major or a joint major program, may complete a program consisting of two extended minors, an extended minor and a minor, or two minors. # SCUS 15-03

# School for the Contemporary Arts Changes to the BA in Visual Culture and Performance Studies

The SCA would like to make two changes to the BA in Visual Culture and Performance Studies.

**One:** The SCA would like to change the name of the Visual Culture and Performance Studies major to **Art, Performance and Cinema Studies**.

**Rationale:** The name change reflects more accurately the actual instruction offered, as well as the expertise of the faculty. The name change will also aid in recruitment as it better articulates the scope of the offerings within the major and is more easily explained to potential students. In addition, the old name proved to be very challenging for student recruitment; the addition of "cinema studies" to the name will assist in recruitment.

**Two:** At the same time we wish to introduce a <u>reconfiguration</u> of the major into two <u>streams</u>: one in <u>Art</u> and Performance Studies and one in Cinema Studies.

**Rationale:** By reconfiguring the major into two streams, the program will be more distinct and will accommodate student interest in particular areas of focus. No new courses will need to be developed; existing program courses are being reorganized within the two streams, and some interdisciplinary electives will be added.
