UBSD Discipline Summary

File # 01-6*	Nature of Offence Academic dishonesty. Plagiarism.	Outcome Tribunal found the student committed academic dishonesty. The President accepted the recommendation of the Tribunal and suspended the student for six semesters.
03-14*	Academic dishonesty. Two incidents of plagiarism in the same department in different semesters.	Student admitted dishonesty. The majority of the Tribunal recommended a one semester suspension; one member of the Tribunal recommended a minimum of three semesters. The President suspended the student for one semester.
03-15	Academic dishonesty. Student allowed tutor to write the final exam in student's place.	Student admitted dishonesty. The majority of the Tribunal recommended a nine semester suspension; one member recommended a six semester suspension. The President suspended the student for six semesters.
03-16	Academic dishonesty. Plagiarism.	Student admitted dishonesty. Previous incidents of academic dishonesty on record in same department. The President accepted the recommendation of the Tribunal and permanently suspended the student from the University.
03-17	Academic dishonesty. Cheating in mid-term exam.	Student appealed the departmental finding of academic dishonesty. The Tribunal upheld the department finding and found that the student engaged in academic dishonesty. Departmental penalty (grade of zero in midterm) to stand.
03-18	Academic dishonesty. Plagiarism in 3 courses in same department in the same semester.	Case pending. Student left Canada. Note placed on student's file – unable to register or obtain an official transcript until case has been resolved.
04-1	Academic dishonesty. Plagiarism. Student submitted own work that had been done when student informally audited an earlier offering of the course.	Student appealed the departmental finding of academic dishonesty. The Tribunal upheld the student's appeal and instructed the department to delete any record of academic dishonesty in the student's file.

04-2	Academic dishonesty. Plagiarism.	Student appealed departmental finding of academic dishonesty. The Tribunal found that the student committed plagiarism. The Tribunal found that the mark of 'F' on the term paper was sufficient sanction and the Department was directed to delete any record of academic dishonesty in the student's departmental file.
04-3	Academic dishonesty. Plagiarism.	Student admitted plagiarism. The President accepted the recommendation of the Tribunal and suspended the student for one semester. Penalty imposed by the Department (F in assignment) to stand.
04-4	Academic misconduct. Student submitted fraudulent letters of reference from SFU faculty members for admission to other universities	Student admitted academic misconduct. The President accepted the recommendation of the Tribunal and suspended the student for six semesters.
04-5	Academic misconduct. Student submitted fraudulent recommendation from an SFU faculty member for admission to another university.	Student admitted academic misconduct. The President accepted the recommendation of the Tribunal and suspended the student for three semesters.

Senate Committee on Disciplinary Appeals Reporting Period: November 2003 to October 2004

The Senate Committee on Disciplinary Appeals dealt with two appeals in the period covered by this report.

One dealt with T10.93, 8.1(c), "that the penalty imposed on the student is excessive in all the circumstances of the case" and one dealt with T10.03 8.1(a) "that a procedural error occurred of sufficient magnitude that it may reasonably be said to have affected the fairness of the process or altered the outcome of the case against the student".

In both cases the appeals were not upheld and the original decisions stood.
