Acting under delegated authority, Senate Graduate Studies Committee, at its 8<sup>th</sup> November 2004 meeting, approved the following new courses, course changes and curriculum changes in the Faculty of Education.

GS 2004.32

(a) Change of title and Calendar description: EDUC 816 Developing educational programs and practices for diverse educational settings

(b) Change from 4 to 5 credit hours: EDUC 846 and 847

GS 2004.33

(c) Reinstatement of EDUC 972. (This course was inadvertently dropped from the Calendar, but the intention was to change it from a required course to an elective)

GS 2004.34

(d) New course: EDUC 842-5 Sociocultural perspectives on the psychology of development and education

(e) Change of title and Calendar description: EDUC 860 Contemporary psychology of education and instructional applications

(f) Title change and change of credit hours from 5 to 4, EDUC 970: Systems and paradigms in the psychology of education

(g) Change of title and Calendar description, and change of credit hours from 5 to 4, EDUC 971 Advanced topics in educational psychology

(h) Change of credit hours from 5 to 4, EDUC 975

(i) Minor changes to PhD program in Psychology of Education, notably change in title to Educational Psychology

(j) Minor changes to masters programs in Psychology of Education, notably change in title to Educational Psychology, incorporation of M.Ed. options to bring the program in line with other masters programs in Education, and better definition of streams.
