In total, I have published 36 refereed journal articles, written seven books and 34 chapters in books, and also gained close to a million dollars in research funding (mainly from SSHRC) and produced two professional videos. I have been a member of Senate for two years. Ways must be found to make it easier for students to participate by, for example, setting the SCIA-approved budgets for these field-schools at a more reasonable level.
.....on-campus services for the 700 or so international students are minimal and SCIA should assist in addressing this shortfall.

.....international development and education projects should be strongly linked to academic departments and faculties and to the universities academic objectives. Such linkages have existed in some but not all projects in the past.
