The Senate Committee on Enrollment Management and Planning and the Senate Committee on Academic Planning have recommended the following actions for consideration by Senate:

Motion on New Undergraduate Admission Targets for 1988/89

"That Senate approve and recommend approval to the Board of Governors the undergraduate admission targets for each basis-of-admission group and for each semester in 1998/99 as set out below and that SCAP be delegated authority to make adjustments based on changes to the overall enrollment targets and based on actual enrollment experience in 1998-2 and 1998-3.

Admission Targets For New Students

In order to match the provincially funded FTE target, the intake of new students would have to be reduced from 5,072 admitted last year to 4,250. The Senate Committee on Enrollment Management and Planning felt that this reduction in the number of new students was too steep and would significantly raise admission averages and would induce an enrollment perturbation that would take several years to move through the year levels. The Committee therefore moved to raise intake targets to 4,500 students. The 250 additional students would be admitted in 1998-3 and would be allocated to the Faculties by the Vice-President Academic in consultation with the Deans.

Motion on New Undergraduate Admission Targets to Faculties

" That Senate approve and recommend approval to the Board of Governors the undergraduate admission targets to each Faculty as set out in the table below and that SCAP be delegated authority to make adjustments based on changes to the overall enrollment targets and based on actual enrollment experience in 1998-2 and 1998-3.
