Action undertaken by the Senate Committee on Academic Planning/Senate Committee on Undergraduate Studies gives rise to the following motion:

**Motion:**

"That Senate approve and recommend approval to the Board of Governors as set forth in S.89-61 the proposed guidelines for a Joint Honors Degree in the Faculty of Arts."

The Faculty of Arts Curriculum Committee has approved the addition of a Joint Honors Program as an option for students completing the degree Bachelor of Arts in the Faculty of Arts. A new section outlining the requirements would be included under the Bachelor of Arts degree information in the Calendar.

### **Joint Honors Program Requirements**

At least 132 semester hours of credit which include


- at least 65 semester hours in Arts subjects
- at least 60 semester hours in upper division courses which must include at least 28 semester hours in upper division courses in each of the two honors subjects\*
- lower division prerequisites for at least one Arts honors program
- satisfaction of the Faculty of Arts Breadth Requirements (see below)
- satisfactory completion of an honors essay jointly supervised by and acceptable to both honors departments.

Students are required to maintain a GPA of 3.0 in the upper division courses in each of the subjects of the Joint Honors Program.

\* A department may designate up to 12 semester hours of program related upper division courses offered by other departments as being acceptable in fulfilling part of this requirement.
