
MOTION: "That the Senate Policy Committee on Scholarships, Awards & Bursaries report annually to Senate in June of each year"


Regarding the section of Committee listings pertaining to the three committees for which I am secretary, pages 26 - 31 inclusive, in your compendium entitled, Committee Listings - dated November 9, 1987. I would like to request that you make the following minor adjustments:

1. On page 26, under Responsibilities, #6 - I would suggest that the deadline date be either June or, preferably, July. Budget year end is March 31, final reconciliation of accounts through Finance are normally not completed until the last week of April or first week of May; our office must then develop a report based upon budget information and statistics which are reconciled through our committee minutes to the revised figures we receive from Finance. Our report must then go to SCAR prior to the Senate meeting.
2. Page 26, under Responsibilities, #1 - should read quote "to adjudicate all Undergraduate private and University awards".
3. Page 30, under Responsibilities, #1 - should read "to adjudicate all Graduate private and University awards".
