1. APPROVAL OF MINUTES

### 3. PROPOSED GRADING SYSTEM

That the grading scale proposed by the President's Committee be adopted with the exception of the explanation for the letter grade DEF.

That the explanation for the letter grade DEF include the sense of the proposal forwarded by the Arts Faculty for the letter grade "I".

#### Registrar's Rewrite:

The letter grade DEF will be given when a physician's certificate or other document substantiating a request for deferment on medical or compassionate grounds is received by the Registrar within four days of the date from which the examination was to have been written

or when the Instructor in the course wishes to defer submitting a final mark pending completion of further work from the student. The awarding of the letter grade DEF will be subject to agreement between the Registrar and the Instructor, as will be the method of establishing the new grade.

STUDENT DISCIPLINE

Some members of Senate expressed concern with the paper's concept of punishment. There was some support for the idea that punishment was not becoming outmoded in Society and that the University should not go on record as saying that it was.

Some concern was also expressed over the section dealing with civil offences. It was pointed out that the University had wide latitude in deciding when to call in the Civil Authorities when confronted with an infraction of the civil or criminal law.
