**RATIONALE:**

EDUC 463 no longer exists, so has been removed as an elective.

EDUC 358-3 is offered sporadically and has become primarily targeted as a foundational experience for students with Educational Technology as a primary concentration. As such, it has been removed from the elective list.

Other courses (EDUC 412, EDUC 414, EDUC 428, EDUC 452, EDUC 467, EDUC 477, EDUC 478, EDUC 480, EDUC 481) are related areas of curricular instruction that can become applied areas for students with a background in Secondary Mathematics.
