1. Approval of the Agenda

The agenda was approved as distributed.

2. Minutes of the Open Session on November 5, 2012 The minutes of the open session on November 5, 2012 were approved as distributed.

3. Business Arising from the Minutes

There was no business arising from the minutes.

4. **Report of the Chair**

The Chair welcomed the new Senate Assistant & Electoral Officer, Kris Nordgren, who will be temporarily replacing Shelley Gair while she takes on a temporary position in Graduate Studies. The Chair thanked Shelley for her service to Senate. The Chair also welcomed Scott McLean, the new acting Director of Public Affairs and Media Relations.

The Chair reported on his recent visit to China, Taipei and Hong Kong; agreements were signed, relationships were built, and the Chair attended SFU alumni receptions. The Chair felt that SFU is seen as an important player in China, particularly by the Canadian embassy, consulates and trade offices. The Chair noted that the high level of investment in post-secondary education and research in China and Hong Kong is the reason Chinese universities are up in the rankings with respect to the rest of the world. The Chair intends on making the argument that investment in research and education is the key to support SFU's opportunity agenda presented to the provincial government.

In terms of labour relations, the Chair said it was gratifying that the TSSU agreement was reached and ratified. The Chair acknowledged that the University has not reached an agreement with CUPE and that job action is likely to be ongoing. The University will continue to try to reach a settlement as quickly as possible and to minimize the disruption to students and programs.

The Chair ended his report with three significant good news items. First, the Canada Foundation for Innovation (CFI) announced that 25% of its funding will be going to British Columbia and that \$8.7 million is going directly to SFU. Secondly, CIDA announced that SFU's Beedie School of Business and UBC's Keevil School of Mining were successful in their joint bid for \$25 million in funding for an institute looking at extractive industries. Finally, SFU was successful in renewing its relationship with the China Council for International Cooperation on Environment and Development (CCICED) as the lead agency on behalf of international partners. Environment Canada has now confirmed funding through to 2017. The Chair congratulated all those who contributed to these successes.

P. Hibbitts, Vice-President, Financial Services, and L. Guthrie, Director, Accounting Services, were in attendance to respond to questions.

iv) Centres and Institutes Renewal Applications 2011/2012 (S.12-167)

Senate received information that the Senate Committee on University Priorities, acting under delegated authority, reviewed and approved the renewal of eighteen research centres and institutes for a five year term. The specific list can be found in senate paper S.12-167.

C) Senate Committee on Undergraduate Studies (SCUS)

i) Curriculum Revisions – Faculty of Applied Sciences (S.12-169)

Senate received information that the Senate Committee on Undergraduate Studies, acting under delegated authority, added new courses, and made revisions to existing courses and programs in the Faculty of Applied Sciences (Mechatronics Systems Engineering).

Clarification was requested regarding the proposed changes in S.12-169, specifically the replication of courses that currently exist. It was clarified that there is a two-step process for creating a new course – relabeling and then curriculum revisions – and that this is the first step of that process.

ii) Curriculum Revisions – Faculty of Arts and Social Sciences (S.12-170)

Senate received information that the Senate Committee on Undergraduate Studies, acting under delegated authority, made revisions to existing courses and programs in the Faculty of Arts and Social Sciences (French; History).

Clarification was requested on the minimum upper division unit requirement for the French major in S.12-170. The Chair confirmed that this item would be looked into.

iii) Curriculum Revisions – Beedie School of Business (S.12-171)

Senate received information that the Senate Committee on Undergraduate Studies, acting under delegated authority, added new courses, and made revisions to existing courses and programs in the Beedie School of Business.

Clarification was requested on several curriculum items in S.12-171. Those items are as follows: lower division unit requirements, upper division Psychology requirements, and the prerequisite waiver for BUS 360W in the Business/Psychology joint major program; resource allocation for new course BUS 475. The Chair confirmed that this item would be looked into.

iv) Curriculum Revisions – Faculty of Communication, Art and Technology (S.12-172)

Senate received information that the Senate Committee on Undergraduate Studies, acting under delegated authority, made revisions to an existing course in the Faculty of Communication, Art and Technology (Interactive Arts and Technology).

v) Curriculum Revisions – Faculty of Education (S.12-173)

Senate received information that the Senate Committee on Undergraduate Studies, acting under delegated authority, made revisions to existing courses and programs in the Faculty of Education.

vi) Curriculum Revisions – Faculty of Science (S.12-174)

Senate received information that the Senate Committee on Undergraduate Studies, acting under delegated authority, added new courses, and made revisions to existing courses and programs in the Faculty of Science (Biomedical Physiology and Kinesiology; Management & Systems Science; Earth Sciences; Biological Sciences; Math; Statistics & Actuarial Science; Physics).

Clarification was requested on the prerequisites for the course change to BISC 418 in S.12-174. The Chair confirmed that this item would be looked into.

D) Senate Graduate Studies Committee (SGSC)

i) Curriculum Revisions – Faculty of Applied Sciences (S.12-175)

Senate received information that the Senate Graduate Studies Committee, acting under delegated authority, made revisions to an existing program in the Faculty of Applied Sciences (Computing Science).

Clarification was requested on the prerequisites for the course change to CMPT 626 in S.12-175, specifically that the courses would continue to be used in the Computing Science dual degree program. It was clarified that the courses would continue to be used and that the change was for the purpose of academic progress within that program.

ii) Curriculum Revisions – Faculty of Arts and Social Sciences (S.12-176)

Senate received information that the Senate Graduate Studies Committee, acting under delegated authority, added new courses, and made revisions to existing programs in the Faculty of Arts and Social Sciences (History; International Studies).
