COVER LETTER RE: DISSOLUTION OF JOINT MAJOR IN COMPUTING SCIENCE AND PHILOSOPHY

The Department of Philosophy would like to request the suspension of admission to and the dissolution of the Joint Major and Joint Honours in Computing Science and Philosophy. The reason we are putting forward these two proposals at the same time is that there are no current students in the program, nor have there been in the five and a half years it has been in the Calendar.

Background:

When the joint program was originally conceived, it was hoped that because "There is a natural intellectual affinity between Computing Science and Philosophy," including "the very substantial amount of logical inference and abstract conceptual organization required in both fields," (S.07.31) and because "An appreciable number of students taking Computing Science already take Philosophy courses" (S.07.31) that a Joint Major would be attractive to students. Also at that time, there was a popular faculty member (Oliver Schulte) who was cross-appointed in Philosophy and Computing Science, and it was believed that he might attract some students into the joint degree. Unfortunately, the demand did not materialize. One plausible explanation is that the requirements of the joint degree were too onerous, and interested students simply opted for a Major/Minor combination (in 2009 one student did complete a full double-major). Also, by the time the Joint Major made it through Senate, Professor Schulte had moved full-time into Computing Science. Whatever the reasons, the clear lack of student interest indicates that, regrettably, it is time to dissolve the program.

5. The reason for suspension is a *lack of student demand*.

In those 5 years, no students have enrolled in the Joint Major or Joint Honours program.
