Both theoretical and practical perspectives inform the course's approach to the principles of behavioural change (diet, physical exercise, and smoking cessation) and risk factor management. There is an increasing desire, and need, for training of students within the health sciences to understand aspects of cardiovascular disease development, prevention and management as cardiovascular disease is a leading cause of death and disability in Canada and the world. The prevalence of cardiovascular disease is so high that any person working in the fitness of health fields will encounter people with cardiovascular disease. This course will prepare students who are interested in working in these fields with high-level knowledge of this condition.
