

Proposal to Suspend Admissions to a Program

1. All impacted credentials, levels and categories of the degree, and specific discipline or field of study

Graduate Diploma in Foundations of Global Health

2. Location of the program

Courses offered at the SFU Burnaby campus

5. Reasons for suspension of admissions are:

- **Lack of enrollment demand**

The program generates a very low student interest. According to SIMS report, in the past 10 years 14 students registered in the program with only 6 who graduated. The last student in the program graduated in Fall 2015 following a transfer from the Master of Public Health (MPH) program after the student had reached her maximum time.

- **Insufficient resources**

There is a significant growth in the demand in other offered graduate programs offered at the Faculty of Health Sciences (MPH, MSc, and PhD) within the Faculty. For instance, the number of prospective student applications in these programs have increased to 18% in the past five years. The Faculty believes that with limited resources, it should focus on its strengths within these programs with higher growth potential.

- Curricular issues
- Inability to provide appropriate educational environment and/or supports

6. Plan for suspension, including:

- a) Steps taken to consult with students

We currently have no students enrolled in the program.

- b) Steps taken to consult with impacted instructors and staff

The proposal to suspend admissions has been approved by the Graduate Studies Committee (GSC) in FHS. Since there are no courses unique to this program, there will be no impact on the existing curriculum and instructors.

- c) Steps taken to ensure students in the program have the opportunity to complete the program

No current student in the program.

- d) Confirmation of consultation with other impacted departments and faculties

No other departments/faculties are impacted

The Faculty of Health Sciences will not be accepting new students into the Graduate Diploma in Foundations of Global Health program as of Spring 2017.
