**4. Report of the Chair**

**i) Terms of Reference for the Simons Foundation Chair in International Law and Human Security (For Information) (S.17-15)**

After having been approved at the January Closed Session of Senate, Senate was notified that the Board of Governors has approved the Terms of Reference for the Simons Foundation Chair in International Law and Human Security.

**ii) Naming Consultation for the Rajan Family Scholar in Computing Science (For Information) (S.17-16)**

After having been discussed at the January Closed Session of Senate, Senate was notified that the Board of Governors has approved the Naming Consultation for the Rajan Family Scholar in Computing Science.

The Vice-Chair noted the regrets of the Chair, who had commitments in Ottawa and was unable to attend.

The Vice-Chair reported that SFU, UBC, UVic and BCIT hosted two roundtables in January to discuss the requirements, needs and strategy for a B.C. cluster proposal in response to Ottawa's \$800 million innovation network and clusters initiative. Over 18 industry representatives participated in these discussions, which will help determine how best to organize the industry led BC consortium, to compete for these federal dollars.
