Introduction to Astronomy PHYS 190 (3)

A survey of astronomy designed primarily for non-science students, with a strong emphasis on active learning outside the classroom. Covers the development of astronomy from the ancient Greeks through the Renaissance, to the modern view of the cosmos as revealed by the scientific method. Topics include naked-eye observation of the night sky, modern observational equipment and techniques, the solar system, stellar evolution, galaxies, the Hubble expansion, the Big Bang, dark matter, dark energy, and startling new theories of the origin and destiny of the universe. Experiential activities involve active observations of the moon, stars and planets, and introductory experiments in some of the basic physics that astronomers use to explore the cosmos. Students who have received credit for PHYS ~~130, 131~~ 121, 126, or 141 may not take PHYS 190 for further credit. Quantitative/Breadth-Science.

CMPT 101 no longer exists. Physics students typically take CMPT 102 or 120 as their introductory programming course. PHYS 255, which did not exist when PHYS 395 was created, is a more appropriate prereq due to its coverage of Fourier series and differential equations.
