## **Program Dissolution Process**

#### NOTICE TO SUSPEND ADMISSIONS

- 1. Program: Literacy Instruction Certificate Program
- 2. Locations: courses offered in Burnaby and Surrey
- 3. This Certificate is offered by the Faculty of Education.
- 4. Anticipated final dissolution date: 2 years from notice to suspend admissions
- 5. Reasons for discontinuance and dissolution of the program:
  - a. The demand for this program is weak. The number of graduates over the past 4 years is 6.
- 6. Plan for phasing out of program:
  - a. The Undergraduate Programs Committee and the Executive Committee have approved the dissolution. A notice of dissolution will be included on the information materials and website.
  - b. The cognate faculty members have reviewed and approved the notice.
  - c. Students currently enrolled in the program will be informed of the notice to dissolve the program. They will be instructed to meet with the advisor to ensure all certificate requirements are complete before graduation.
  - d. There are a few students from the Faculty of Arts who complete this certificate program. The Faculty of Arts has been notified.
  - e. Students will have the option of the Adult, Youth, and Community Literacy Education Minor Program.
- 7. Once the program dissolution has been approved by Senate, a notation can be placed in the SFU calendar. The Faculty of Education program information website and printed brochures will be updated to reflect the date of dissolution.
