

SENATE SUMMARY

MEETING OF February 6, 2017

1. Report of the Chair

i) Terms of Reference for the Simons Foundation Chair in International Law and Human Security (S.17-15)

The Vice-Chair reported that SFU, UBC, UVic and BCIT hosted two roundtables in January to discuss the requirements, needs and strategy for a B.C. cluster proposal in response to Ottawa's \$800 million innovation network and clusters initiative. Over 18 industry representatives participated in these discussions, which will help determine how best to organize the industry led BC consortium, to compete for these federal dollars.
