At its meetings of 19 July 2018, the Department of Linguistics approved the following curricular program change:

a) Program Suspension: (effective Summer 2018)

All minor students were contacted in the spring and summer of this year and met individually with department assistant Rita Parmar to discuss the impact of this change on their planning, essentially that they can either complete their program on the old system or convert to an extended minor. In October 2018 I have re-iterated the same message to all active minors.

Major curriculum revisions that took effect in Fall 2018 have made the Minor redundant.
