

SENATE SUMMARY MEETING OF APRIL 6, 2020

1. Report of the Chair

The Chair reported that efforts to meet the challenges resulting from COVID-19 are ongoing and continue to be guided by the advice and direction provided to the post-secondary sector by the Provincial Health Officer and by provincial health authorities. SFU is also communicating through *Universities Canada* with the federal government. Via this two-way interaction, SFU receives advice and direction from provincial health authorities, but also communicates some of the needs and concerns of the University, and also recommends actions to be taken. Efforts have been closely associated with other research universities through the *Research University Council of BC*. Acknowledgement was given to members of Senate and those throughout the University community for their efforts to adapt to this extraordinary and unfortunate environment. Concern was raised about the well-being of students, noting that many are suffering a sense of stress and dislocation due changes in teaching methodology, coupled with financial pressures resulting from lost job opportunities and uncertainty. In recognition of this, and in addition to existing support, the COVID-19 Student Support Fund has been launched to raise funds for the University on behalf of students experiencing difficulty. This week the Provincial Government announced \$145,000 in emergency funding towards student emergency assistance. Also, the SFSS has approved an emergency student fund of \$150,000. Considerable effort has been placed in communicating with both levels of government about the student situation and it has been reported that both the federal and provincial governments will announce initiatives around student employment and student financial aid. Work is being done with government to contribute equipment, supplies, advice, facilities and anything that can be used in the efforts to address COVID-19. In this respect, acknowledgement was offered to faculty members in support of COVID-19 efforts:

- Health Sciences Researcher Julia Smith is co-leading an international research team funded by the *Canadian Institute of Canadian Research* to identify gender related effects of COVID-19 and will also identify gaps in preparation and response measures, providing recommendations for those developing policy to improve public health responses.
- Physics professor Nancy Ford has organized a campus supply drive to collect critically needed gloves, face masks and other supplies to be donated to protect health care workers. Many faculty members are also providing expert commentary through main stream media and social media.
- Andrew Wister, Director of the SFU Gerontology Research Center, has provided suggestions for how we can protect and support elders at this time.
- Health Sciences professor Scott Lear has stepped up with a blogpost with how to stay healthy at home.
- Lieke ten Brummelhuis Associate Professor in Beedie School of Business, has provided information on things people can do to manage stress and stay focused while working remotely.

- Psychology professor Lara Akin has shared recommendations on how to maintain resilience and remain happy during these challenging times.
- Business Professor David Hannah shared information on avoiding COVID-19 misinformation and practicing workplace compassion.
- Food Systems Planning researcher Tammara Soma has shared advice on staying healthy and how we can ensure food secured communities during self-isolation and social distancing.

The Chair reported that Laya Behbahani, PhD student in the School of Communication and Director of the Student Experience Initiative, has been appointed one of sixteen 2020 *Trudeau Foundation Scholars* and will engage in a three-year program of education and empowerment. Also, Denise Williams, CEO of the *First Nations Technology Council* and SFU alumnus and member of the SFU Board of Governors, has been named one of the mentors this year by the *Trudeau Foundation*.

The Chair reported that the difficult decision has been made to cancel the in-person June Convocation. Planning will instead focus on providing a vibrant online program to honor Spring 2020 graduates. Graduates will be offered the opportunity to take part in in-person convocation ceremonies in either October or June 2021, as there are plans to expand those ceremonies to accommodate increased numbers so that students will not be deprived of the opportunity to participate in convocation. It was noted that even though students will not convocate in June, they will graduate in June, subject to Senate approval.

Relating to Convocation, the Chair reported that honorary degree candidates have all been notified of the change in plans with respect to June. Their names were announced in conjunction with the announcement regarding convocation arrangements and candidates will be invited to participate in the June virtual convocation celebration, but will also be given an opportunity to attend to October or June 2021 convocation ceremonies. If someone is unable to attend either of those ceremonies, alternate arrangements will be sought, with the approval of Senate, for them to be granted their degrees at a different time.

The Chair reported on recent events:

- The Annual SFU Awards Dinner, which celebrates faculty, students and staff members who have achieved awards over the year, was held at the Diamond Alumni Club on March 5th.
- On March 10th, a luncheon was held to honor the 8 SFU faculty members recognized last year by the *Royal Society of Canada* and the 3 faculty members recognized by the *Canadian Academy of Engineering*.
- Also on March 10th, the Library held their annual Celebration of SFU Authors to mark the achievements of authors of monographs or chapters within monographs. There were 116 SFU faculty, staff, students, alumni and partners who accomplished books or book chapters this past year who were recognized at that event.
