Rationale for having students complete additional course when signing up for CA 830.

CA 827, Practicum in Contemporary Arts, is a letter-graded course because the projects students pursue as a result of these placements are directly related to the research they are conducting in the MA program. The program is unique in that the graded course work students take to fulfill their program requirements is always tied in some way to their individual objects of study (e.g. Iranian national cinema, feminist performance art, gender in contemporary South Asian photography, etc.). This culminates in the final Research Colloquium course (CA 822), in which students publicly present a paper based on the culmination of their studies and tied to their individual research. CA 827 is one another elective option that students can take to pursue a specific community-engaged project (curating an exhibit at a gallery, organizing a public symposium, etc) that emerges from and is directly related to **their original academic research**. They have to make a formal proposal for the project, the supervising institution has to agree to give them the latitude and resources to pursue this project, and they write a substantial paper at the end of the practicum course summarizing the results of their institutional research that is graded by the MA Program Coordinator. By contrast, the proposed MA Internship course (CA 830) **is not directly tied to students' academic research**. Instead, it is **an applied course** in which students take the critical thinking and research and writing skills they have acquired in their other graded required and elective courses and put this to work in the service of an arts organization that will give them additional professional skills (from grant writing to archiving to policy development) that will benefit them in their post-academic careers. They are being directed in the substance and execution of this work by their field supervisors (instead of proposing their own projects) and the reviewed outcome is a much shorter reflection paper. We are proposing this course as an additional credit option for our students in order to give them the opportunity for important institutional training; however, we still want them to take the same number of academic and research-related courses that assigned letter grades. In this way, the students who take CA 830 will graduate with the same rigorous research-based academic degree as their peers, while also gaining value-added professional training.

We are also onboarding two non-credit professional practices seminars, CA 890 and CA 891, which were created in conjunction with our new PhD program.</p>
<p>Rationale for change:</p> <p>We are creating a paid internship course, CA 830, for students in our MA program seeking paid training in a workplace setting related to their field of study and/or career goals. This course will be distinct from our unpaid and graded MA Practicum course, in which students are placed with a partner organization in order to complete an applied research project of their own devising related to their studies. Because assessment for CA 830 will be satisfactory/unsatisfactory, we are changing our required total units from 33 to 35, 30 of which will be graded. We are also introducing two options for students' course electives, as students interested in taking CA 830 will need to take an additional graded elective course. CA 890 and CA 891 have been designed for all graduate students working in contemporary arts to gain additional non-credit professional development skills related</p>
